## JANUARY TOWN BOARD ACTION

January was a busy month for Town Board business. Following is a report on some of the decisions made which residents of Center will want to be aware of:

• The new DENTAL CLINIC is moving closer to reality. The Town Board has agreed to serve as the grantee agent for Valley Wide's application to DOLA (Colorado Department of Local Affairs) for \$600,000 for renovation of the former Kingdom Hall. Following a public hearing, the board also approved rezoning to commercial use for that property at 135 6th Street. Construction of the new dental clinic will begin in 2020. There will be no cost to the Town for this project.



- A conditional use permit was approved for a NEW BUSINESS at 714 Broadway. Enrique Aguilar
  will construct a new building to house his planned vehicle alignment business. We are anxious to
  see this project develop and to have this needed service in Center. Go Enrique!!
- The Board approved a request by Jade Communications, an Internet provider from Alamosa, to locate equipment on our new water tower to provide INTERNET AND TELEPHONE SERVICE to the citizens of Center. This will give us three choices for this service: CenturyLink, Ciello, and now Jade Communications.
- CODIFICATION IS COMPLETE! After several years of work by the current Town Board as well as
  the previous town board, all of Center's ordinances (laws) have been reviewed, updated, and
  compiled into an organized manual for easy reference. This completes one of the 2018 goals set
  by the Town Board. The manual is available at the Town Hall for any citizen wishing to review it.
- The Board decided to keep the TIMES AND DATES for Town Board meetings the same for 2019. Board meetings will continue to be held on the second and fourth Tuesdays at 6:30 pm.

## DOG LICENSING AND VACCINATION TO BE ENFORCED



The Town Board also discussed the dog situation we have here in Center. Love 'em or hate 'em, we do have a lot of dogs in Center. And many are running at large. We've had several vicious dog incidents and reports of people being intimidated by dogs running loose. We feel that the answer lies with dog owners being responsible to see that their dogs are licensed, vaccinated, controlled, and cared for. Dogs are not the problem. Irresponsible dog owners are the problem.

Police officers, animal control, and code enforcement will be citing any and all owners in violation. If you have more than one dog, ALL need to be licensed and vaccinated.

Fines could lead up to \$100 per violation.

#### BUSINESS AND CONTRACTORS' LICENSES: TIME TO RENEW

All business and contractors' licenses expire on December 31 and require renewal January 1 every year. If you are operating a business within the city limits, you are required to have a business or contractor's license. Citations will be issued.

### CENTER SNOW REMOVAL POLICY BEING FOLLOWED

Homeowners are responsible for removing snow from sidewalks, driveways, and parking areas. Our maintenance crew removes snow only from streets per our policy.
