CITIZEN COMMENTS -

Juan Villagomez – Mr. Villagomez has a horse that he considers a pony. When the Villagomez's asked for permission to have a horse it was supposed to be a miniature horse. The horse is not a miniature. The Board is concerned that it is against the ordinances. A motion to not allow Mr. Villagomez permission to keep the horse in the Town of Center due to it being an ordinance violation was made by Trustee James Sanchez, seconded by Trustee Adeline Sanchez. Roll Call – All in favor. Motion Carries. Mr. Villagomez has 30 days from March 26 to remove the horse from the Town of Center.

CONSENT AGENDA -

Minutes – There was a change to the March 26^{th} minutes. Rose had Trustee McClure making the motion and also seconding the motion.

Police Department – The Department did hire two new officers, they will be taking a training program prior to being on their own. The new officers are Colten Murphy and Christopher Williams. Officer Murphy will also be finishing his EMT. Another concern has been the evidence room. Katrina Martinez will become the evidence technician. Beatrice Gutierrez will be the secondary key keeper. There was methamphetamine which has been destroyed in the proper manner. Trustee Adeline Sanchez asked if Interim McClosky has had a chance to look at the policy manuals. Interim McClosky has not had a chance to look into the current policies and will look into a policy for the evidence. Officer safety is a real concern, if the bar continues to have issues about fighting they will have to look further into the

liquor license. Another concern was the wages that the officers are currently receiving; they are one of the lowest paid in the Valley. Interim McClosky would like the Town to be competitive with the wages. The Dept. did receive a complaint about the phone not being answered in dispatch. That has been corrected. Interim McClosky wanted to thank Sgt. Arellano for giving a driving course prior to his resignation.

Court Report - There were no questions.

Public Works Reports -

Utilities – There was one question on the boring that would be done for the electrical upgrade.

Waters-Dave will have the crew look for a possible leak behind the old Ford Garage.

Streets and Parks - There were no questions.

Code Enforcement Report- There were no questions.

Attorney Trujillo recommends that the Town approve moving forward with the augmentation plan. The project may take up to one year to get a plan filed. There are a few wells that need a decision on how to use them. A motion to move forward with the augmentation plan was made by Mayor Pro-Tem McClure, seconded by Trustee Adeline Sanchez. Roll Call – All in favor. Motion Carries.

NEW BUSINESS -

LA SIERRA BAR – LIQUOR LICENSE RENEWAL – Attorney Trujillo recommends that they do renew license but would like the owner to be present at the next meeting. A motion to approve the liquor license with the license holder to appear at the April 23, 2019 meeting was made by Trustee Adeline Sanchez, seconded by Mayor Pro-Tem McClure. Infrastructure Upgrades – The plan is to break ground on the water meter project will be around June 15, 2019. There are some houses that are connected together. The funding for the project is as follows; \$144,280,000 loan from CWPA and a \$1,000,000 grant from DOLA.

Sidewalk to Tierra Nueva – The subject of putting in a sidewalk was discussed, Brian will look further into the cost.

Park Improvements – Brian said that we are waiting to apply for a GOCO grant to continue improving the parks.

Enforce Dog Ownership Requirements – Brian said that he would like everyone tag their dogs on a calendar year starting in 2020.

Eliminate Blight around Town - Dave has started issuing citations for the blight.

PARK GATE – Dave sent out seven cost inquires and has received two replies that it is out of their service area. The issue will be tabled until the next meeting.

Center School – Obed Perez with the Senior class proposed to paint the middle light Viking colors with a little Viking. A motion to allow the proposal with the Town purchasing the paint and the brushes was made by Trustee Adeline Sanchez, seconded by Trustee James Sanchez. Roll Call – all in favor. Motion Carries.

NEW BUSINESS

- A. Jennie Carter Center Head Start Donation No one was present at the meeting.
- B. Maria Espain Selling of Products Ms. Espain would be selling accessories for women and men, party favors, and blankets. A motion to table the issue until May 14 so she can bring all her documents before the Board was made by Trustee McClure, seconded by Trustee Hurtado. Roll Call – All in favor. Motion Carries.
- C. Anita Rodriquez- Center Schools Donation -No one was present at the meeting.
- D. Tony Garcia Property Set Backs Mr. Garcia will be 11 ft. short on the second St. and 10 ft. short on the Warden side. Trustee McClure would like for the Board to have a discussion about the current condition of the property. A motion to table the issue until they can have a discussion and answers Trustee McClure, seconded by Trustee Hurtado. Roll Call All in favor. Motion Carries.
- E. Street Paving Trustee Adeline Sanchez said that the Town needs to look at the streets that had been previously prioritized. Dave said that they are looking at coming behind the electrical upgrade to finish all the paving where they have cut. Dave is waiting for a price cost from Saguache County.
- F. Rogelio Aguilar Property Set Backs Dave would like to inform the Board that Mr. Aguilars mobile home burned and he would have to replace it. Mr. Aguilar would be setting back 40 ft. from the center of the street. The mobile home will be set on the same spot. A motion to approve the set back if he places the mobile home in the same spot or with a few feet to the north was made by Trustee McClure, seconded by Trustee Adeline Sanchez. - G. Water Testing There is a 3 yr. and a 9 yr. mandatory testing schedule. Both requirements will cost \$6857 for the two wells. A motion to approve the water testing was made Trustee McClure, seconded
- H. La Sierra Bar The owners of the Bar were present at the meeting. The Board wanted to know what they are doing to curb disorderly conduct, they told the Board that they do have security that monitors the inside of the bar. Trustee James Sanchez would like the Bar to have more

security during big events. The Board told the owners that they want them to notify the Police about the events so that there are enough officers on duty, the owners agreed that they would notify the Town. The Town Board worries about kids being in the bar. The owners stated that they could keep them in a different area for special events.
