

WATER ISSUES FACING CENTER

Water usage in Center continues to be a problem. We are overusing our water, and many people are

still failing to follow water restrictions. Citations with higher fines for repeat violations are being issued.

Water is an issue in the water-scarce West, and good citizenship requires that we all conserve.

One solution to excessive water use is water metering. With metering, the more you use, the more you pay. The State of Colorado has required water meters for several years now. The Town Board is looking at how we can meet the requirements.

If you see some activity on the Consaul property wells, don't be surprised. The Town is working with

the State Water Engineer to ensure that our wells meet the requirements of the State Water Plan.

IF IT'S SEPTEMBER, IT MUST BE AUDIT – THEN BUDGET – TIME

The Town is in the middle of the audit process, and we will soon know how our financial system is working. We feel that we have made good progress in managing and accounting for Town funds.



The audit will help us in planning the 2019 budget. This takes several months. The budget is due to the State at the end of December.

We will have workshops to learn and make decisions to create a good, sound budget that will meet Center's needs. We welcome input from the community. The workshops are open to the public.

CITIZEN VOLUNTEER NEEDED

The Town is setting up a temporary committee to study and decide on how Town properties are classified as resident or commercial for utility billing. If you are interested in serving on this committee, please notify the Town Hall.
