

AN ORDINANCE PROVIDING FOR THE NUMBERING OF BUILDINGS.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF CENTER, COLORADO:

Section 1. It is hereby made the duty of every owner, agent or person in possession of any building in the Town of Center, Colorado, within twelve months from the passage of this ordinance, to number it in the manner herein provided:

Section 2. The decimal system of numbering buildings in said Town of Center is hereby adopted. Even numbers shall be used on the east and south sides of streets and avenues; odd numbers shall be used on the north and west sides of streets and avenues; Broadway Street and First Street are hereby adopted as division lines, and buildings on streets running east and west shall be numbered to the east and to the west, respectively, from Broadway. Buildings on streets running north and south shall be numbered to the north and to the south, respectively, from said First Street.

Section 3. One hundred numbers shall be allotted to each block in the Town of Center, starting with 100, and the apportionment shall be approximately one number to each three feet of frontage, and in case of irregularities, appropriate numbers shall be assigned by the Town Clerk, it being intended hereby to preserve, as nearly as possible, a general uniformity in numbering buildings throughout the Town of Center.

Section 4. All building numbers shall be of metal, plastic, porcelain, or other durable substance, or may consist of lettering on the inside of a glass window, door or transom, and shall be conspicuous and distinctly legible and not less than three inches in height.

Section 5. The Town Clerk shall, within thirty days after the passage of this ordinance, assign a series of numbers to and for each block within the Town of Center, and from time to time thereafter, prepare and keep on file in his office appropriate maps, sketches, drawings or records, to preserve an accurate record of the numbers assigned or allotted to the respective buildings within the Town of Center.

Section 6. In all cases of mistakes or conflicts of building numbers, or where some special arrangement is necessary in consequence of irregularity of streets, avenues, blocks or public ways, the Town Clerk shall direct and make proper adjustment in accordance with the intent and spirit of this ordinance.

Section 7. Upon request of any owner, occupant or agent of any building within the Town of Center, the Town Clerk shall assign to such building its proper number and the same shall be placed upon said building as herein provided, within thirty days thereafter.

Section 8. Every owner, occupant or agent of any building within the Town of Center who shall fail or neglect to comply with this ordinance shall, on conviction thereof, be fined in a sum not more than \$25.00, and costs of prosecution; and each day's continuance of the act forbidden or required shall be deemed a separate offense and punished accordingly.
