Monthly Report from the Public Works Director Town of Center

As we enter the new year, the Public Works Department has identified several key projects and initiatives aimed at enhancing the infrastructure, efficiency, and overall quality of life in our community. Below is an overview of our plans and progress for 2025:

1. Safe Routes to School (SRTS) Project

We are continuing work on the SRTS project to improve pedestrian and student safety. Key components include:

- Installation of new sidewalks, crosswalks, and pedestrian signage near school zones.
- Upgrading lighting in high-traffic areas to ensure visibility during early morning and evening hours.
- Collaboration with school officials, CDOT, and Davis Engineering to improve and promote safer walking and biking to school. This project is expected to start in spring.

2. Downtown and 3rd Street Improvement Project

The revitalization of the streets in the Downtown area and 3rd Street remains a priority. Our plans include:

- Street rotomilling, resurfacing, and reconstruction to improve drivability and extend the lifespan of roads.
- ADA-compliant sidewalk installations to enhance accessibility for all residents.
- Beautification efforts such as roundabouts, tree planting, possible pedestrian signlights, and benches to attract more visitors and businesses.
- Partnering with local contractors to ensure timely completion of this project while minimizing disruption to businesses and traffic.

3. Utility Software Upgrade

To enhance operational efficiency and service delivery, we are moving forward with:

- Implementing upgraded utility meter reading software to provide residents with more accurate and timely information.
- Transitioning to a system that integrates electric, water, and gas meter data for better monitoring and management.

Training staff to use the new system effectively, ensuring a seamless transition. This
upgrade will result in better service for residents and more efficient management of town
resources.

Once upgrad is done, the focused will be to:

- Upgrading the town's electrical substations to meet increased demand and improve reliability.
- Replacing aging components to prevent outages and reduce maintenance costs.
- Collaborating with engineering consultants and contractors to adhere to project timelines and budgets. This project underscores our commitment to providing reliable electricity for residential and commercial users.

4. N90 Project

The N90 project, a critical infrastructure initiative, is focused on:

- As of today, the RFQ (Request for Qualifications) for Professional Engineers for Phase 1
 of the N90 Project has been sent out and posted on the Town of Center website,
 Facebook page, and in local newspapers.
- The next steps include reviewing RFQ submissions by the stated deadline (January 30th)
- Presenting the submissions and evaluations to the project team.
- Obtaining approval for the selected engineer from Town staff and the Town board.

5. Water Meter Implementation

A significant focus this year will be the installation of water meters in areas currently without them. This includes:

- The Housing Authority, mobile home parks, and several residential properties.
- Coordinating with residents to ensure minimal disruption during installation.
- Educating users on water conservation practices and the benefits of metering. This
 initiative aims to promote equitable billing, water conservation, and long-term
 sustainability of our water resources.

Other Updates:

- Staffing and Training: Ensuring our team has the necessary tools and knowledge to execute these projects effectively.
- **Community Engagement:** Hosting informational meetings and maintaining open communication to keep residents informed about progress and gather feedback.
- Grant Opportunities: Actively pursuing grants to offset costs for these and future projects.

The Public Works Department is committed to advancing these projects with transparency, efficiency, and community involvement. We look forward to collaborating with residents, businesses, and stakeholders to achieve our goals for 2025 and beyond.

WATER OVERVIEW

1. Drinking Water Monitoring Schedule

We are completed this year's monitoring schedule and the results all met State requirements.

2. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system. The West Well stopped operating in the automatic mode. The well will run when it is in manual. We had Central pump out to help us diagnose the issue. They has to order a new digital screen for the well in order to run a full diagnostic. The part just came in, so we should have more information in the near future.

3. Water Quality

We conducted water quality assurance calls to customers as directed and we did water turn on and offs as needed.

4. Projects

We were able to meet the end of the year deadline for compliance with the backflow prevention installation and testing. We sent out the required notices to all of our customers that have service lines that contain lead, galvanized metal or are unknown materials. The Lead and Copper Inventory will begin its next phase of unknown service line verifications in the next couple of months.

5. Water Tank

The monthly Water Tank inspection was completed with no issues.

6. Other Tasks

Making sure that water meters are installed at all service connections and that they are properly reading has been and will continue to be a major project and a high priority. We worked on fixing the fencing around the West Well, the biggest challenge around that was that it was during the holiday season and many of the local businesses were closed.

SANITATION OVERVIEW

1. Process Control Monitoring

We continue to run daily process control tests. Even with the drop in temperatures, we have not had to adjust the wasting yet.

2. Lift Station Checks

Daily lift station checks have been completed.

3. Sewer Obstructions

We have several calls this last month on sewer issues and backups. We have addressed the sewer calls as they arise.

4. Jetter Truck

As the temperatures have remained consistently around freezing temperatures, we have not used the vactor truck other than in emergencies.

5. Sampling and DMR's

We have continued sampling and testing the water weekly. Our plant has continued to produce high quality effluent. We are working with a couple of companies to get all of our lab equipment calibrated and on an annual schedule for calibration moving forward.

6. Plant Operations

Our decant pump is still in Denver being rebuilt. We have replaced the UV bulbs in one of the banks to test out the overall quality. So far they seem to be working. We have continued to trouble shooting the fan press and are pretty sure we figured out what the issue is.

7. Other Tasks

The apprentices have been working on assignments and trainings as well as completing their day-to-day duties. We just completed the annual

A motion to go into the budget hearing and have the Town Attorney Michael Trujillo as the hearing officer was made by Mayor Pro-Tem Bieriger, seconded by Trustee Lopez. Roll Call –All in favor. Motion Carries.

Public hearing-

Attorney Trujillo explains that during this meeting the citizens can ask questions or anything concerning the 2025 budget. Paula Martinez was also able to help answer those questions. Town manager Cole goes through the budget packets and starts stating the amounts. Trustee McClure raised concerns about errors in the resolution, particularly regarding the separation of street improvement funds into two reported accounts. Trustee McClure also mentioned issues with accessing the town's budget, which he was told wasn't available despite it being a public record. Trustee McClure expressed concerns about rate increases, including the mil levy and utility rates, and questioned the rationale behind these hikes. Trustee McClure also pointed out that during workshops, his request to discuss employee salaries went unanswered, despite a proposed 12.5% pay increase in the 2025 budget. He highlighted the bookkeeper's salary of \$82,000, including a \$300 travel fee, and suggested that the bookkeeper should oversee utilities.

Trustee McClure also raised an issue with billing errors, noting that the town pumped 231 million gallons of water but only billed for 115 million, pointing to significant accounting issues. Trustee McClure requested that the 2% utility rate increase not be approved.

Paula Martinez responded, explaining that the town's end-of-year fund balance was off by \$200,000 and that reports could not be provided on a daily basis due to government accounting regulations. Paula Martinez justified the rate increases as necessary to address inflation and maintain the town hall. Paula Martinez clarified that she does not set salaries and that future salary increases would be based on performance. She also noted that she consults with auditors for any questions.

Mona Garcia expressed the need to carefully monitor finances. Adaline Sanchez questioned the inclusion of additional items in the budget, to which Trustee Lopez explained that those funds came from ARPA, not taxpayer money, and had to be used within a specified time.

Mary McClure suggested pay should be based on qualifications, referencing an example of Anthony Lucero's pay being unfairly lower. Trustee McClure disagreed with some salaries, using the code enforcement officer's \$56,000 salary as an example, suggesting it might be better combined with the public works director's duties.

A motion to close the public hearing was made by Trustee Gonzalez, and seconded by Trustee Barela. Roll Call –All in favor. Motion Carries.
