#### APPROVAL OF AGENDA

A motion to approve the agenda with an addition to New Business was made by Trustee Gallegos, seconded by Trustee Beiriger. Roll Call –All in favor. Motion Carries.

#### CITIZEN COMMENTS

Susan Banning- Wanted to talk to the Board about the increase of fires. Ms. Banning stated that when she was Mayor there was a survey about the masts on houses that need to be replaced. She would like to know what progress has been made in the last ten years in regards to the masts and the housing Inspections have been done on converting old fuse boxes. We as a Town need education. People need to have a fire safety program about the necessity of Carbon monoxide detectors. Newsletters in English and how many are needed in Spanish?

#### CONSENT AGENDA

Minutes – No Questions were asked.

Court Report – There was no court in December, all fines were paid a head of time.

Police Report- Chief Fresquez said that there has been an increase in traffic tickets. There were a few different tickets and warrants. There was a fire in Town to which the police responded. There will be a basketball tournament that will be donated to the fire victims, Officer Adolph asked the Chief if they could do that and he agreed. There are a few investigations currently in progress. The Valley Police Departments are helping each other out and Chief Fresquez and Corporal Fresquez are trying to form an

interdiction unit between the departments. Chief Fresquez is working on more grants, the current grant due Friday is a Homeland Security Grant. Chief Fresquez would like to get a mobile speed limit sign with the grant. There are applications for new hires.

Public Works Dept. Reports

Utilities- The Pathway project will be talked about later on in the agenda.

Water – The commercial water meters are failing. The Town does not have a plan on replacing them. Dave will have a dollar amount as to the cost of replacing the meters. Mayor Pro-Tem Martinez asked if the Town was having sewer problems. Dave said that he was not aware of any problems.

Streets and Parks - No questions were asked.

Building Report – Eighteen violation letters were sent out. Dave is going to start with minor violations.

A motion to approve the Consent Agenda was made by Mayor Pro-Tem Martinez, seconded by Trustee Barela. Roll Call – All in favor. Motion Carries.

#### **PAYABLES**

A motion to approve the payables was made by Trustee Gallegos, seconded by Trustee Gonzales. Roll Call –All in favor. Motion Carries.

#### MANAGERS REPORT

507 Miles RV — Brian said that the homeowners are requesting to place a camper trailer while they rebuild the house, once the house is rebuilt they will remove the camper. Brian also explained that the Town has a donation check for \$500 to help with any needs they may have. A motion to approve the camper being used until the house is rebuilt was made by Trustee Gallegos, seconded by Trustee Barela. Roll Call — All in favor. Motion Carries.

#### PUBLIC WORKS DIRECTOR

Gourmet Gas – Colorado Gourmet is requesting the Town sell them gas at a wholesale price. Dave doesn't feel that there is any room on the gas line especially now that the Town is looking to expand. Brian feels that there is not enough information and Colorado Gourmet should come before the Board explaining what they are proposing and what they would like to accomplish. A package should be put together by Dave as to the issues that the Town would face if what Colorado Gourmet is proposing were to be allowed.

VFD Approval – The VFD went out on the East Well. A motion to purchase the VFD from Central Pump at the cost of \$12,149.55 was made by Mayor Pro-Tem Martinez, seconded by Trustee Barela. Roll Call – All in favor. Motion Carries.

Water Annual Gallons – The Town has decreased by eight million gallons. The Town has decreased usage since 2019.

SLV CD- Contract –The Contract is ready to turn over to the Water Conservancy District for approval. The contract includes all of the wells including the wells at the North 90. A motion to approve the contract and send it to the Water Conservancy District for approval and or any changes was made by Trustee Gonzales, seconded by Trustee Beiriger. Roll Call – All in favor. Motion Carries.

Electric Transportation – If things stay the way that they are supposed to as part of the Pathway project. The PUC did approve this Pathway project. The Town and several other municipalities are being hit hard with this project. The Town is already contacting our representatives. The next step is FERC; the lawyers are filing with FERC in February. Xcel is currently charging nine cents more than the Town is currently charging. The Board asked Dave to keep us informed.

#### RESOLUTIONS/ORDINANCES

Electric Ordinance – Attorney Trujillo highlighted the areas which allow Dave to adjust the charge of the electric. It is mirroring the gas ordinance. Attorney Trujillo read the ordinance out loud. A motion to approve Ordinance #566 was made by Trustee Beiriger, seconded by. Roll Call –All in favor. Motion Carries.

Resolution for Support of the San Luis Central Railroad grant and a non-binding resolution – The project will be for Ansel to Center's station to replace current railroad lines. Brian read the resolution out loud. A motion to approve resolution #01102023 was made by Trustee Barela, seconded by Trustee Gallegos. Roll Call -

#### **NEW BUSINESS**

Alta Convenience – Liquor Renewal – Attorney Trujillo said that everything looked in order and there have been no violations. A motion to renew the Liquor License was made by Mayor Pro-Tem Martinez, seconded by Trustee Beiriger. Roll Call – All in favor. Motion Carries.

Michael BonDurant – Veterans Officer – Mr. BonDurant introduced himself as the new Veterans' service officer. He works under the County and the State Department. Mr. BonDurant is there to help veterans with claims. The program is for those that are in need of different things including utilities. Mr. BonDurant is in Center on the 2<sup>nd</sup> Thursday of each month. Mr. BonDurant would like ideas on how to reach Veterans.

Recast City – Brian talked about working with DCI since 2019. The Recast Leaders contract is the next step in moving forward. The consultant will talk and train on how to rebuild your downtown areas. There are Team Center meets every Wednesday. Dave is now involved since it is moving forward and Rose will be slowly brought in so that we have more involvement within for the project. It has been paid with the 2022 budget, it costed \$14,005. A motion to approve the Contract was made by Trustee Gallegos, seconded by Trustee Gonzales. Roll Call – All in favor. Motion Carries.

24 hr. Disconnects – Brian talked about the amount of disconnects are being sent out. Brian is recommending that we do away with the 24 hr. disconnects after a three-month education to the customers about paying the past due amount that is on their bill. A motion to vacate 24 hr. disconnects was made by Mayor Pro-Tem Martinez, seconded by Trustee Beiriger. Roll Call – All in favor. Motion Carries.

2023 Meeting Schedule – Mayor Pro-Tem Martinez recommended that if a meeting is going to be lengthy to provide snacks and water.

Vehicle Purchase – The Police Dept. did receive a grant for \$145,000 toward salaries. Chief Fresquez requested that since the sixth and seventh positions are already budgeted for if they could purchase a new Truck with the budgeted amounts. A motion to purchase a new truck for the police department was made by Trustee Gallegos, seconded by Trustee Barela. Roll Call –All in favor. Motion Carries.

Mary McClure who sits on the board and was in attendance at the Town Board meeting said that they have been having a hard time filling the positions. It is a volunteer position. until the Town Board is given answers to the advertising and a copy of the by-laws to make the decision was made by Mayor-Pro Tem Martinez, seconded by Trustee Gonzales. Roll Call –All in favor. Motion Carries.

**Fixed Asset and Capitalization Policy**- Brian talked about having the policy and that it is needed to apply for certain grants. Paula took the information off the audit as to what was needed. A motion to approve the Fixed Asset and Capitalization Policy was made by Trustee Gallegos, seconded by Trustee Barela. Roll Call – All in favor. Motion Carries.

Transformational Affordable Housing Grant – Brian had a meeting with the Center group on Friday. The group has received applications in the amount of over \$750,000,000 of the \$150,000,000 available. Brian said that they thought they had time to put in the application. The application is due January 31, 2023. Dave and Brian have been scrambling to have the application ready. There is a match for infrastructure and the Town could apply for up to \$10,000,000. There are also low interest loans that may be able to help. If the Town were to receive the amount requested the match could be 2.5 million. A motion to authorize Brian to apply for the grant and anything that may come up that pertains to the grant and is not monetary was made by Mayor Pro-Tem Martinez, seconded by Trustee Gallegos. Roll Call – All in favor. Motion Carries.

Rosco Engineering – Approval – A motion to approve the Rosco Engineering contract and the cost will be out of the Economic Development was made by Trustee Beiriger, seconded by Trustee Gonzales. Roll Call –All in favor. Motion Carries.

## WATER OVERVIEW

## 1. Drinking Water Monitoring Schedule

We just started a new year's monitoring schedule and so far so good.

## 2. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system with some variation entry point.

## 3. Water Quality

We conducted water quality assurance calls to customers as directed and we did water turn on and offs as needed.

## 4. Projects

We continued to work on surveying for the backflow program. Pictures of backflows have been uploaded on Diamond Maps to also help us track the different devices and locations. We have been working on getting all of the paperwork filled out to get some of the guys signed up for the apprenticeship program. Commercial water meters are still being manually read.

#### 5. Water Tank

We have completed the Water Tank inspection for the month. The Water Tank is in good condition.

#### 6. Other Tasks

We had a Sanitary Survey on January 4th 2023. We had a few violations, some from the past that we are unable to address or change. A couple of the violations are for our ongoing backflow project that we have worked really hard to get up to par. We are continuing to get the backflow program back on track and in compliance. Other than the backflow violations the sanitary survey went really smoothly. I have been working on the response to the Sanitary Survey Letter. I applied for an alternative Backflow Survey Compliance Ratio to allow us more time to get back into compliance. I have also worked on the Violation notices to send to the public. Two of the violations were a Tier 2 which means the public has to be notified within 30 days.

## SANITATION OVERVIEW

## 1. Process Control Monitoring

We continue to run daily process control tests. There's nothing to report as all the numbers have been good.

## 2. Lift Station Checks

Paily lift station checks have been completed. All the lift stations are running with two pumps.

## 3. Sewer Obstructions

There were very few calls for sewer problems this past month.

## 4. Jetter Truck

Bid paperwork for the jetter truck has been submitted to USDA for their approval. I have been working on a grant proposal to obtain the remaining funds for the jetter truck.

## 5. Sampling and DMR's

Labs are becoming more routine. All the numbers continue to be good. DMR's have been submitted and we are in compliance. We are running all but two tests in house now.

## 6. Plant Operations

We have continued to iron out overall operations and identify issues to be addressed as they come up. We have been working on putting together a preventative maintenance program for the equipment at the Treatment plant. We had the initial startup for the fan press. We have processed a bit of sludge cake with the sample polymer that we had. We are waiting for more polymer to arrive to continue the process. Warranty work on the decanters has a tentative date of early April.

## 7. Other Tasks

The Board voted on new rates that were implemented this last month. Updating policies has been an ongoing project.

## Water/Sanitation

CDPHE completed our Sanitary Survey on January 4 and we had 2 tier 2 violations which have already been correct. And 2 Tier 3 violations regarding the backflow testing program. We are working closely CDPHE field technicians to remedy the violations.

As of Feb. 6 all of the new trucks have arrived and are getting prepped to be put into service.

## Proposal for continued upgrade and addition of new service

This proposal is to acquire the service addition of Skyview cooling to our grid system currently provided by Excel energy and could be completed as follows:

It would require two bores of wire from the junction box located at east side of road across from Gourmet Potato to the site on west side of road in the property of the Skyview Cooling system. Calculating the load that will be added to our new system, this would be beneficial to the Towns electrical revenue and would probably pay for the upgrade and takeover of these services within three years.

The Town could sell the transformer purchased for Maverick that they neglected to pay for and could sell this transformer to Skyview Cooling for a dis-counted price to recoup the losses of the purchase of said transformer. Although we need to hire a crane to move the transformer to the new location we could also pass the cost of moving and setting the transformer to the new location to Skyline Cooling.

The Town has the underground wire in stock to complete this task and would only have to purchase the elbows to complete the task. The only other thing that would be out of pocket for the Town would be the concrete to pour a new pad for the re-location of said transformer. The other cost for the Town would also be the utility crew's labor to complete the task (installing elbows, cabinet and the forming and pouring of the pad).

The work for this job and takeover would need to be completed before the lettuce harvesting season set to begin about the 1<sup>st</sup> of July of this year. Also the Town maybe could also acquire the services for the camps South of Highway 112 that is currently being provided by Excel for their power to the camps and to the old ice plant there. I believe this will benefit the Town by providing more revenue for the Town going into the future.

Please let the utility crews know what we can work out for this and will just need to know the price we would charge Skyview for the transformer. At that point the crew would be able to assemble all of the pricing and costs involved to complete the proposed project.

### **Theater updated service requirements**

After meeting with Vemco Electric for the design and upgrade of the electrical service for the old theatre in town they are requiring upgrade to a 1000 amp service. This will require the utilities to upgrade the transformer to feed the services in the alley. The transformer would have to be increased in size to a 500KVA to feed the new service and also continue with the service upgrades the Town is currently performing. Since this project has begun there has never been a mention of this large of service and believe they should be responsible for the cost of the upgraded and larger transformer needed to handle this electrical load. This will also have to have larger overhead wire installed to this service than originally planned for the project. They are going to heat the building with electric heat and have also mentioned of the installation of 4-5 RV spaces.

# **507 Miles**

A portion of this home was burned in a fire in late December of 2022. The homeowners are taking appropriate steps to remove the remaining structure from the property.

They are planning on putting a new modular home on the property that will require a Zoning Variance approved by the Board of Trustees.

The property is a corner lot which requires 8,000 sq. ft. to construct a home on, this property only encompasses 7,000 sq. ft.. So a variance is needed to allow the placement of a modular home on the property.

The property will also need a setback variance so the setbacks can be adjusted to bring the structure in line with the rest of the neighborhood. This will allow the home to look like it belongs in the neighborhood. The ordinance would push the home back into the property and out of line with the rest.




