PUBLIC WORKS DIRECTOR

Skyline – Change of Utilities- Skyline on Torrez they are still hooked up to Excel. Skyline has approached the Town to see if they could connect to the Town's utilities. Chris Nelson said that they would have to dig the utilities to connect. The Town also has the transformer that is at Growing Springs for \$31,000. They already have quotes for the boring. Chris would like guidelines as a cost to Skyline. A motion to charge Skyline \$30,000 for the transformer and part of the cost of the boring was made by Trustee Duran, seconded by Trustee Gallegos. Roll Call- All In favor. Motion carries.

Theater – Service – The owners would like to make this property All Electric. They would need to change the transformer. They would be responsible for the upgrade. Attorney Trujillo mentioned that they better be on Board with the cost of this upgrade. Brian said that it will not be another Growing Springs issue. All that was needed was a 112 service, they want a bigger service. A motion to approve the purchase of a transformer for \$25,000 plus all costs was made by Mayor Pro-Tem, seconded by Trustee Duran. WATER AND SANITATION DEPARTMENT FEBRUARY 2023 REPORT

3/8/2023

WATER OVERVIEW

1. Drinking Water Monitoring Schedule

We just started a new year's monitoring schedule and so far so good.

2. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system with some variation at entry point. We ordered a more robust dosing pump that can handle the lower dosing speeds without compromising the gears. We have not installed the new pump as the other two dosing pumps are still operational.

3. Water Quality

We conducted water quality assurance calls to customers as directed and we did water turn on and offs as needed.

4. Projects

We continued to work on surveying for the backflow program. Pictures of backflows have been uploaded on Diamond Maps to also help us track the different devices and locations. We have been working on getting all of the paperwork filled out to get some of the guys signed up for the apprenticeship program. Commercial water meters are still being manually read.

5. Water Tank

We have completed the Water Tank inspection for the month. The Water Tank is in good condition.

6. Other Tasks

The two Tier 2 violations, that require the public to be notified within 30 days were sent out with their utilities bill and a copy of the notices were posted at Town Hall as well as the Post Office. I have applied to the State for an alternate Backflow compliance plan to bring the Town back into compliance. We have not received a response to the application yet. The East Well is up and running again after being out of commission due to VFD problems.

SANITATION OVERVIEW

1. Process Control Monitoring

We continue to run daily process control tests. There's nothing to report as all the numbers have been good.

7. Lift Station Checks

11

Daily lift station checks have been completed. All the lift stations are running with two pumps. We are getting quotes on cleaning out a lift station from RMS Utilities, Browns Septic, and Weaver's Level Best.

8. Sewer Obstructions

There were very few calls for sewer problems this past month. We have had multiple calls on sewer issues this past month. We had a call for a sewer obstruction in the alley behind the Family Dollar. When flushing the sewer line, the jetter hose got stuck. The operators tried to get the hose unstuck. Without any success in freeing the hose, they eventually had to cut it. We trouble shot and exhausted many different possible solutions. With the help of Weaver's Level Best videoing the sewer main we were able to locate the jetter head. We are currently working on getting the hose and head removed.

9. Jetter Truck

We are still waiting on USDA to approve the bid paperwork for the jetter truck. I presented my grant proposal to the Saguache County Commissioners, which was approved for what we hope is the remainder of the cost for the jetter truck.

10. Sampling and DMR's

Labs are becoming more routine. All the numbers continue to be with in parameters. DMR's have been submitted and we are in compliance. We are running all but two tests in house now. I am currently working on submitting the Reg 85s to the State.

11. Plant Operations

We have continued to iron out overall operations and identify issues to be addressed as they come up. We have been working on putting together a preventative maintenance program for the equipment at the Treatment plant. We have learned a huge amount about the plant and operations of all the equipment involved in the plant over the past 10 months. We continue to learn and become better at troubleshooting issues.

12. Other Tasks

Updating policies has been an ongoing project. We are also looking into different avenues to get the collection system inspected.
