APPROVAL OF AGENDA - A motion to approve the agenda with changes was made by Trustee McClure, seconded by Trustee Beiriger. Roll Call – All in favor. Motion Carries.

CITIZEN COMMENTS -

Brian Lujan – Brian talked about the work that they have done with the North 90 and several agencies. Talked about the issues that they have issued against him.

Mona Garcia – Ms. Garcia said she is not here to argue. Center News has done worse that Mitch has done. Ms. Garcia requesting that the staff treats them with dignity and respect. Ms. Garcia said that the high utility bills. Ms. Garcia feels that all her dog tickets are retaliation. Ms. Garcia was concerned about the cost of the court costs.

Geraldine Jaramillo – Mitch Garcia asked her to read comments. Mitch is a fellow member of the Colorado University bishop leadership program also part of the Public crisis program. Mr. Garcia also is part of several other groups and programs. Police Department – Mr. Garcia found that there was a difference in the website and the Town's website for archiving. Mr. Garcia said that he contacted the administrator about the Town's website and it is separate.

CONSENT AGENDA

Minutes - No Questions were asked.

Court Report – Natalia explained the reports. Natalia thanked the Board for her position.

Police Report – Chief Fresquez, Chief spoke about his term as a chief. The Department is short officers. There is a lot of negativity and it is part of the job and hiring. The security cameras are in; they are waiting for the SD cards to come so they can get them in use. There are not drones as has been indicated. There is a direct line for them to stay away from the machines. The Department is going to start doing interviews. Saguache County will help the Town.

Public Works – Jaime spoke about the gas and the electric. Jaime is keeping a close eye on the gas. There was a huge bill, Jaime and Dave talked with Excel. Excel feels that there was an error on their side. Jaime did send an email asking for an update. Backflow was in compliance at the end of the year, and are working on this year's compliance. The vehicles for the auction – maybe have a silent auction. Utility bucket truck – 10 – 12 thousand to get it fix, should we fix it or sell it. The Street Dept. would like to have a bucket truck. Mayor Garcia asked about the year and more information in an email. Clean up days will be paused. The County is providing five dumpsters in Crestone, Trustee McClure talked to the Commissioners. Jaime is looking in to it. Brian spoke to Wendy who will bring it up at the next Commissioners meeting. They are trying for weekend prior to Earth Day. The Town is having issues with the current shelter. Jaime is thinking about maybe housing the animals at the North 90, if they are not picked up they can take them to Alamosa. Jaime did terminate the contract with the current shelter as of March 11th.

Utilities - The Dept. is working on the underground utilities.

Water – The Water Dept. are working on the housing departments to get them online for the meters.

Streets and Parks - They will start cleaning the alleys and right of ways.

Code Enforcement – Some issues are older than six months and would like updates as to the status. Jaime will mail the list to the Board. Sergio has been helping other departments. Mayor Garcia and Trustee McClure talked about the flashing speed limit signs. Jaime will follow up with Randy at the County.

A motion to approve the Consent Agenda was made by mayor pro-Tem Martinez, seconded by Trustee Gonzales. Roll Call – All in favor. Motion Carries.

PAYABLES

Mayor Pro-Tem Martinez asked about the descriptions, Rose will email a copy to the Board. A motion to approve the payables was made by Trustee Barela, seconded by Trustee Gallegos. Roll Call –All in favor. Motion Carries.

PUBLIC WORKS

VFD PURCHASE APPROVAL – The cost of the VFD is \$9,168.50. A motion to approve the purchase of the VFD was made by Trustee McClure, seconded by. Roll Call – All in favor. Motion Carries.

MEGA DUMP TRAILER - Trustee McClure said that the Sanitation District should also pay for the trailer since they will also use it. The cost of the trailer is \$8,500. A motion to approve the purchase of the Mega Dump Trailer was made by Mayor Pro-Tem Martinez, seconded by Trustee Barela. Roll Call –All in favor. Motion Carries.

MANAGERS REPORT

Brian said that Keith wanted to report on the Art project. The Town received a \$20,000 CHAFA grant for the beautifications in Town. It is time to solicit artists. Keith handed out the proposal to the Town Board.

RESOLUTION

GOCO RESOLUTION – This is required for the GOCO Grant, Attorney Trujillo did say that it did look good. Brian read the resolution out loud. The Town has requested \$536,000 for the Community Park. A motion to approve Resolution 2024-2 GOCO Grant was made by Mayor Pro-Tem Martinez, seconded by Trustee Beiriger. Roll Call – All in favor. Motion Carries.

NEW BUSINESS -

Susan Banning – McKinny Vento and Housing in Center – Ms. Banning was at the meeting. Ms. Banning teaches at the Center schools and is the liaison. Ms. Banning said that she had to correct herself from the last meeting.

What can the Town Board do? Ms. Banning is recommending a RV park, either temporary or permanent. There are trailers behind houses with no electricity, water or sewer. Ms. Banning would like housing for middle income families.

Approval of WSLV Grant Awards – The Town Board reviewed the grants last week. There were seven applications, there was approx... \$9,225. All applicants were able to receive grant money. Trustee McClure read the awards out loud and what they use of the request. Brian added that the Office of Economic Development is going to do a video about what the Town is using the fund for. A motion to approve the WSLV Grants was made by, seconded by. Roll Call – All in favor. Motion Carries.

Utility Bills – The post office has changed the way the bills are being delivered. Trustee McClure talked about bills being received late. Get the information out about the bills not being delivered. Flyers and

Temporary Wage Increase for the police Department – Brian talked about a wage increase like they did with the Utility Department. The Town is currently \$4 under the local agencies. There will be further workshops for beginning wages. The utilities were \$5 an hour increase. The Chief will also be compensated accordingly. K9 event will still have the coverage in Town.

OLD BUSINESS

MEAN CONTRACT – Lock ourselves in a lower rate with a 25- year contract or continue on the five - year program that will have a higher rate. The Board will have a workshop to see which would be the best option for the Town.

PROPOSED ZONING CODE UPDATES – Keith asked about the updates. The planning commission has a meeting on March 18th. Short term rentals, the question is still not clear, but Keith recommends that they stay at 3. The Town has sent RFQ's to qualifications for developers. Trustee McClure asked if they could contact the Army Corp of engineers. Abandoned homes in Center. Keith did not find very many people willing to sell or rehab their homes.

Brian discussed the difference between Salaried and Exempt Employees. Chief Fresquez is an exempt employee – the Chief is an exempt employee. Chief Fresquez will stay exempt with the extra time paid in a form of a bonus of 3% and will be visited every 30 days. Paula has done three different scenarios for the increase in wages for Police officers that are not exempt. Cpl. Fresquez pay will go to \$31 per hour during the shortage and all officers our off of program. All new officers starting pay will be \$23.50 for six months and will move to 24.50 after. Every Town has its issues but this is been the worst behavior. Community advocate – they are having a positive change, but not in Center. Community advocate- is a joke, a clown and a mockery. This is Child- like behavior in this Town. Other communities are coming together as a community to make things better, instead of pointing fingers. SCceed is doing the same thing for Saguache. Work together positively. It's a shame that good people are being driven away.

They are looking for a donation for the car show – they would like a \$400 donation for different needs. Gearhead Gala is the name of their car show. MORE HOUSING NOW – Keith said that he has been working on the housing infrastructure grant for the underground infrastructure – approx. 30- unit housing development. Max amount is 2 million with a match of 25% \$450,000 – \$500,000 costs to the Town. The Town should be able to accommodate the match. Brian said that we are looking at a smaller development. The Town had been denied 10 million prior grant applications. The Sanitation District will also match. ARPA can be used as a match. The North 90 will be a good long term economics for the Town. A motion to approve the starting of the application for the More Housing Now grant was made by Mayor Pro-Tem Martinez, seconded by Trustee McClure. Roll Call – All in favor. Motion Carries.

OLD BUSINESS

APPROVAL OF ZONING CODE UPDATES – Keith was speaking for the planning commission. The planning commission would like a motion to pursue the updates. They did remove the short term rentals. The Planning commission needs to work in enacting the updates. A motion to approve the preliminary approval of the updates was made by Trustee McClure, seconded by, Trustee Beiriger. Roll Call –All in favor.

MEAN CONTRACT — Megawatt vs. the KWH. KWH is smaller unit; it is the placement of the decimal point. We can continue on the 5 year plan and see where we are at. If we go with the 25 yr. plan then we are locked in for the entire time. The cost is the difference in the plans. Trustee McClure feels that the 5 year plan is the way to go to monitor the green energy. We are currently at \$45 a KWH and with the 5 year it will go \$74 a KWH. This will close the gap to the consumers. It could possibly be a cost to the consumers. Trustee Beiriger also thinks that the 5 year plan is a good idea. The 25 year option does give the Town a place on their Board and have a voice. Brian gave a recap of going with MEAN vs. Xcel.

Center Post-Dispatch – Has the Town done an analytical study or is the Town waiting for a unified decision. The Town did have an Analytical study prior to going with MEAN. Paul Lopez – would the Town be able to have a buy back policy. Brian said that they would like to have a resolution. The cost of the electricity will always be a cost to the Town. There is an ordinance at this time preventing private homes from installing solar panels. Jennie Doran asked if disconnects will they change, if rates go up. This is still unknown. A motion to sign the MEAN Contract for the 25 years was made by Mayor Pro-Tem Martinez, seconded by Trustee Gallegos. Roll Call – All in favor. Motion Carries.

Public Works Director Report

Hello everyone, I hope you all are doing well this evening and that you all had a very happy Easter. I apologize for not being present to give my report at this meeting, some of the utility guys and I had a MEAN training scheduled for today April 9th-10th in Glenwood Springs. This month's report is fairly short but to the point.

I would like to start by saying that all departments are working and preparing for the spring and summer seasons. A VIN inspection was done by Chief Fresquez on the dump trailer as required by the board, and everything came back good and in order.

The inspector for Cirsa is coming (April 18th) to do building inspections and all departments are working on getting things ready and making changes/fixing items recommended by inspector on March of 2023.

Also, an update on the newest members of our family (utility crew). Once a month I have a Supervisors meeting to get an update on their departments and after meeting with the department's supervisors, the Utility Supervisor stated that both new members are doing very well and catching up fast. They both are doing well on all their training and certifications, they both took and passed the on-call training, but he would feel more comfortable to start scheduling them to be on-call after their lineman training.

Tierra Nueva will be implementing 20+ new water meters for their residents. Each resident then will have to come and open an account accordingly. As you read this report, Tierra Nueva is working with a company to install all meters and backflows.

One question that has emerged on the Sanitation side was, how many times should we (Town and Sanitation) flush a sewer line before there is a charge? About 3-4 months ago, there was a local business that called out our sanitation and utility crews to work on their sewer line 4-5 times in one week. The sanitation board is looking into it and will be implementing it in their policies.

Last but not least, as you all remember, last month in my report I talked about the January Xcel (gas) bill. The amount for January was \$405k. The Town Manager and I have been in backand-forth communication with Xcel.

- 2/28/24 I called Xcel and spoke to someone at customer services, and at first they
 advised me that "they believe there was a decimal error on their end and that they
 were going to review numbers/formulas and get back to us". In the meantime, they
 were NOT going to draw payment until the issue was resolved.
- 3/12/24 After not hearing anything from them, I called and was told that the bill amount was correct and that they (Xcel) could not do anything about the charge set by the "Transportation Marketer", that they were going to contact us and explain it to us. → heard noting that week.

- 3/25/24 I called Xcel once more and I was told the same information. They stated
 that they only punch in numbers and that it. I asked to speak to their supervisor
 because they could not give us a clear answer of why the bill was so high or tell us
 who the "Transporter Marketer" was. So at that point, we still didn't know who
 this "transporter Marketer" was and either Xcel.
- 3/27/24 I received a call from our Xcel representative She stated that the billing
 was correct and that they based it according to their Transport gas rates that are
 posted monthly with the highest of the 4-week pricing and that this was according

WATER AND SANITATION DEPARTMENT MARCH 2024 REPORT

4/4/2024

WATER OVERVIEW

1. Drinking Water Monitoring Schedule

We are continuing this year's monitoring schedule and results are still meeting requirements. The Bacteria water samples that we take monthly continue to be good (negative).

2. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system with some variation at entry point. We repaired the injector at both the East and West Well.

3. Water Quality

We conducted water quality assurance calls to customers as directed and we did water turn on and offs as needed.

4. Projects

We have been following up with Senses to work on the customer's water meters. We are re connecting the Sensus meters to their original MXU. We got with Set flow and started working on residential meter to get them to read.

5. Water Tank

We have completed the Water Tank inspection for the month. We have started contacting companies to get quotes for the annual comprehensive inspection.

6. Other Tasks

We have been delivering backflow notices to commercial businesses to remind then to retest their devises. The 25 meters that were to delivered SLV Farm Workers were be installed. We continue to go through and organize all of the inventory. We are working on preparing the properties for weed spraying. We have been double checking that everything is in order for when we have the CIRSA inspection.

SANITATION OVERVIEW

1. Process Control Monitoring

We continue to run daily process control tests. There's nothing to report as all the numbers have been good.

2. Lift Station Checks

Daily lift station checks have been completed. Grease is one of the major issues that the Board is looking at addressing in the new policies.

3. Sewer Obstructions

We have several calls this last month on sewer issues and backups. One question that emerged was how many times should we flush a sewer line before there is a charge involved. We brought it up to the Sanitation Board and they are planning on addressing it in their new policies.

4. Jetter Truck

We are still planning on receiving the vactor truck around the beginning of May. We are planning on having all the utility departments train on the Vactor when it arrives.

5. Sampling and DMR's

All sampling and lab work continue to be completed with no issues. We have been working on collecting and testing samples from BOD and commercial customers so that we can have updated data. All of our labs and DMRs have been compliant.

6. Plant Operations

We are working nonstop on the up keep and preventative maintenance for the plant. Plant operations have gone fairly smooth with a few issues along the way. We are currently networking to find the best vendors for spare parts, so we can have an inventory on hand. This is an ongoing project. We have started up the second train for the plant. So far everything is working correctly and the water quality has not been compromised. We also just started up the wasting pump for the second train with no issues.

7. Other Tasks

We continue to work with the Board to update policies, they policies have gone to the lawyer and the engineer for proof reading. We are now just going through and updating the items they recommended. The construction for our office should start soon. We have been spending a lot of time on reworking the policies and gather data especially for the commercial "BOD" customers. We are working with CRWA to finally get the apprenticeship program going again. We are working on putting together an inspection and cleaning program for the collection system. We should have it ready to implement when we get the vactor. This way we have a record keeping of all the lines we flush and a report on the overall state and quality of the manholes.
