Nadine Martinez – Ms. Martinez is present at the meeting on behalf of Mitch. Ms. Martinez said that now that the election is done and the Town is heading in a new direction. Mutual success is community effort. Questions involving funds needs attention. Police Department – dysfunctional.

Mona Garcia – Ms. Garcia said Rose is going on vacation and Natalia will be in charge of Town Hall. April 12th, and April 17th. Judge Zollars took her payment the judge admonished her about not being nice. Mona said she called four times when Rose had left for the day. What if it is an emergency? Audrey Chavez – Ms. Chavez congratulated the New Board members. Would like to get back into customer service go back to Fridays. North 90 – provide ownership and be courteous. Joseph Montoya – Building variances – came last year to get a building permit. Gerald Garcia is built a new Garage. Joaquin Dominguez is building close to the road. Treat him like the people from Mexico.

FINANCIALS

A motion to approve the March Financials with the understanding that the ED fund is removed from the GF immediately was made by Trustee McClure, seconded by Mayor Pro-Tem Beiriger. Roll Call – All in favor. Motion Carries.

PAYABLES

A motion to approve the payables and to cancel and try to get a lower cost the Sirius bill was made by Trustee McClure, seconded by Trustee Sanchez. Roll Call – All in favor. Motion Carries.

NEW BUSINESS

Variance Approvals –

Claudia and Carlos Garcia – The Garcia's want to give 4 ft. of their property to their Mother. The current trailer that is owned by their Mom is sitting on the Garcia Property. The Garcia's will need to get a surveyor for that property. Trustee McClure what would be the follow up from the Town? Mitch Garcia asked why they are going against policy and have a bunch of odd size properties. Trustee McClure said that the Town is not going against policy that's why they are asking for a variance. A motion to approve the variance with the stipulation that everything that is needed is done in 90 days with the follow up was made by Trustee McClure, seconded by Trustee Sanchez. Roll Call – All in favor. Motion Carries. Adrian and Della Duran – The Duran's have a concrete slab that has been there, they would like to put a gazebo type canopy. The issue is they go right up to the fence. A motion to postpone the application until further investigation into the situation as recommended by Attorney Trujillo is done was made by Trustee Gonzales, seconded by Trustee Lopez. Roll call – All in favor. Motion Carries. Jaime Hurtado – The Hurtado would like to put up six ft. pillars block fence in between with a possible metal fence on top of the fence to keep out weeds. The property sits back far enough so it won't impact being able to see from traffic. A motion to approve the variance for the fence was made by Trustee Gonzales, seconded by Trustee Barela. Roll Call – All in favor. Motion Carries. Mike Martinez – The fence on Anna Martinez property is not in compliance with the policy. Trustee

The Martinez's would like a letter from the Town that the fence is okay where it. It has a 10 ½ ft. encroachment. Anna Martinez who currently owns the house would like to renovate the house and cannot do it until the issue is settled with the Town. Trustee Sanchez recommends that the Town give him a letter. The current fence is in line with the other houses. A motion to provide the letter to Ann Martinez after she gets the variance and pays the fee was made by Trustee Gonzales, seconded by Trustee Barela. Roll Call – All in favor. Motion Carries.

Rio Grande Weed Management – Armando and Lowell helped last year with the goat heads. \$4149 to spray all the parks and 8000 gallons of water. Armando would like it to be tabled so the new Board can review the contract. They use non-restrictive chemicals to rid of all obnoxious weeds. A motion to postpone approving the contract until the next meeting was made by Trustee McClure, seconded by

Mayor Pro-Tem Beiriger. Roll Call –All in favor. Motion Carries.

Ed Fund – May 1st Motion to \$300 out of the fund and put into Colorado Trust. Leave \$25,000 in the bank. The ½ % - take it directly to the Colorado Trust was made by Trustee McClure, seconded by Trustee Sanchez. Roll Call – All in favor. Motion Carries. The Board needs to set a financial policy.

Tower Lease – A motion to postpone the Tower Lease monies was made by Mayor Gallegos, seconded by Trustee Sanchez. Roll Call – All in favor. Motion Carries.

OLD BUSINESS

Xcel Gas Bill — When the Town received the bill, Jaime and Brian contacted Xcel and they started the investigation into the pricing. The explanation is that the Town of Center is the only Municipality that is unregulated via back up sales. Xcel can raise our prices but they cannot change our tariffs. Xcel are going to provide to the Utility Commission a new proposal or the Town can find a 3rd party seller. Trustee McClure said that this has happened a few times. In January the cost went up to \$3.50 due to a high demand in the winter. The Town needs a representative from Xcel that we can go to. We need to file a complaint from the Town of Center on how they could raise the rate so high. Attorney Trujillo can file the report. Michelle McKnight is the representative and can come and talk with the Board. Authorize Jaime to work with Attorney Trujillo and write a letter to governor Polis also. Trustee McClure would like to also be involved. A motion to file a complaint with Governor Polis from Trustee McClure, Attorney Trujillo and Jaime was made by Trustee Sanchez, seconded by Trustee Lopez. Roll Call —All in favor. Motion Carries.

Dispatch – Made arrangements with Saguache temporarily - Paying \$1000 a month for dispatch, original plan is still to move them to CSP. The plan is for June or July cost may be \$10,000 a year.

PUBLIC WORKS - UPDATE

Jaime Hurtado introduced all the department workers to the Board – Jaime gave the Board a copy of CRS and our policy. Jaime said that they have had issues with the Board contacting individuals on their days off. The New contract for Mean contract will end March 2025. CIRSA was here last week. There are a lot of things that we need to take care of. The Auditors were here also. Back flow was installed last week at the Town. Tierra Nueva installed 25 new water meters. Clean up was successful, although they were filled up by ten. Solar systems – are coming into Town. The Town has no policies for the Solar system, Mean is recommending a policy.

Public Works Director Report

Good evening mayor and board of trustees, here is brief report for this moths Public Works Director.

Water/Sanitation:

- Attended meetings (online) with SUNRISE Engineering regarding Lead and Cooper inventory projects.
- There were several calls last month about sewer issues and backups, but those were taken care of. One question that has emerged is "How many times should sanitation flush a sewer line before there is a charge involved?".

Utilities: (Electric and Gas)

- Fifty delinquent notices went out; three were disconnected and reconnected after payment.
- Attended a couple of meetings (online) with engineers working on our gas distribution system modeling.
- Attended a couple of meetings (online) with MEAN and Exigent Energy to obtain quotes on generators for the Town of Center in case of a power outage.
- Working with Utilities and IT to create google sheets for better inventory keeping, tools, equipment, reports, etc.
- Met with the Town Attorney to discuss board recommendations (Backset issues on 3rd/White St. Property, Drafting a letter to the Governor about Xcel, among other issues).
- This past week gas went up from \$1.70 to \$2.27. As of right now, we have had an increase of .42 from April 1st to May 10th.

Street & Parks:

- Attended a Pruning class with the Colorado State Forest Service and got some information about some more possible grants for trees through the IRA program.
- o Planting of new trees at the community park, Chamizo, Central, and Casa Blanca.
- o Clean Casa Blanca restrooms.
- Fertilized parks
- Put tables on the Central Parks gazebo.
- o Repairing flag poles at Casa Blanca.

Code Enforcer:

- So far this year as of today 5/10/24, there have been 31 building permits.
- Follow up with some new building permits.
- Helped the Street and Parks crew with snow plow and daily duties around town.

WATER AND SANITATION DEPARTMENT APRIL 2024 REPORT

5/9/2024

WATER OVERVIEW

1. Drinking Water Monitoring Schedule

We are continuing this year's monitoring schedule and results are still meeting requirements. We got bac-T done and came back good.

2. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system with some variation at entry point. We changed the Cl2 barrel at the West and East Well.

3. Water Quality

We conducted water quality assurance calls to customers as directed and we did water turn on and offs as needed.

4. Projects

A list of customers has been created and updated on who needs back flow for retesting. We have been working on meter to read on the computer. We also addressed a few calls on low water pressure. The SLV Farm Workers have installed meters and backflows. We now have to set up time to work with SLV Farm Workers to activate the meters. SLV Farm Workers met with the town and are now trying install one backflow prior to all of their buildings so they only have to test one for the year. Casa Blanca Park backflow has been replaces with a new one.

5. Water Tank

We have completed the Water Tank inspection for the month.

6. Other Tasks

Backflow compliance for commercial water meters continues to be ongoing projects. We are hand delivering 60-day reminder to commercial water users that have tested. We are checking high usage to let customers know for passible leaks.

7. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system with some variation at entry point. We repaired the injector at both the East and West Well.

SANITATION OVERVIEW

1. Process Control Monitoring

We continue to run daily process control tests. There's nothing to report as all the numbers have been good.

2. Lift Station Checks

Daily lift station checks have been completed. Grease is one of the major issues that the Board is looking at addressing in the new policies.

3. Sewer Obstructions

We have several calls this last month on sewer issues and backups. One question that emerged was how many times should we flush a sewer line before there is a charge involved. We brought it up to the Sanitation Board and they are planning on addressing it in their new policies.

4. Jetter Truck

We recently got word that the delivery of the vactor truck has been delayed to the beginning of July. We are still planning on having all the utility departments train on the Vactor when it arrives.

5. Sampling and DMR's

All sampling and lab work continue to be completed with no issues. We have been working on collecting and testing samples from BOD and commercial customers so that we can have updated data. All of our labs and DMRs have been compliant.

6. Plant Operations

We are working nonstop on the up keep and preventative maintenance for the plant. Plant operations have gone fairly smooth with a few issues along the way. We are currently networking to find the best vendors for spare parts, so we can have an inventory on hand. This is an ongoing project. We have started up the second train for the plant. So far everything is working correctly and the water quality has not been compromised. We also just started up the wasting pump for the second train with no issues.

7. Other Tasks

We continue to work with the Board to update policies, they policies have gone to the lawyer and the engineer for proof reading. We are now just going through and updating the items they recommended. The construction for our office should start soon. We have been spending a lot of time on reworking the policies and gather data especially for the commercial "BOD" customers. This Memorandum of Understanding is being entered into by and between Rio Grande County Weed and Pest District (RGCWeed) and Town of Center to establish the provision of weed control services provided by RGCWeed to Town of Center.

The Power plant, old water tower and K9 housing facility encompasses approximately 1.9 acres and will require approximately 5 hours of labor and treatment with 96 oz of Cornerstone EPA 1381192, 96 OZ Rangestar EPA 42750-55, 48 OZ 800 Plus, 128 oz Plainview and 19 OZ Rejuvra. This estimate total is \$1,289.08

The Water Treatment Plant encompasses approximately 3.5 acres and will require approximately 5 hours of labor and treatment with 224 oz Cornerstone, 224 oz Rangestar, 32 oz 8 Plus, 192 oz Plainview, 24.5 oz Rejuvra. This estimate total is \$1,702.62.

City Park encompasses 2 acres and will require approximately 5 hours labor and treatment with 96 oz Cornerstone, 96 oz Rangestar, 48 oz 800 Plus and 32 oz Rejuvra. This estimate total is \$1,157.84.
