2021 ECONOMIC DEVELOPMENT GRANT GUIDELINES

Eligibility:

- A. Grants are only awarded to municipalities or counties that are members in good standing of the San Luis Valley Council of Governments (SLVCOG)—current dues paid.
- B. Multiple applications per member jurisdiction will be considered for funding this year provided projects are benefitting multiple economic or community development outcomes. For example, a COG dues paying member may apply for a small capital improvement project with a budget up to \$20,000 (award amount \$5,000) AND a mini grant to assist with marketing, web development or the likes also with a budget of no more than \$20,000 and award of \$5,000. Hence, more than one project per entity may be applied for in 2023.
- C. After the grants have been awarded, any change in scope to a funded project must be submitted in writing to the SLVCOG Executive Board for approval and a new agreement will be signed.
- D. All grants require a minimum 1 to 1 cash match.
- E. Maximum grant reimbursement per request is \$5,000; project size limited to \$20,000.
- F. Grant funding will be paid on a **reimbursement** basis only.
- G. The SLVCOG board reserves the right to adapt these guidelines to serve the needs of communities and to adjust the amount of available funding.
- H. Applications will be reviewed on a first-come, first-serve basis. In the event that there are still funds available after June 30, 2023, applications will FIRST be reviewed for communities who have not yet applied for or received funds for the current year. <u>Jurisdictions who have already received funds for current year and are applying for remaining funds will be wait-listed to accommodate first-time users.</u>
- I. Acknowledgement of the San Luis Valley Council of Governments is encouraged on marketing materials, name plates, etc.

Use of Grant Funds:

- A. Eligible projects may begin once the SLVCOG and DOLA have fully executed their contract for 2023 AND the SLVCOG grants project approval with the same being fully executed in the form of a contract for the project. All work must be completed, invoiced and paid for no later than December 31, 2023.
- B. Funding will be awarded to projects that demonstrate contributions to **Economic Development** needs of the community including but not limited to:
 - Economic Development projects including façade improvements for the city or county, energy efficiency assessments and improvements, Main Street/Community assessments, and community mapping,

- ii. Small scale capital improvements projects—not vehicles or attachments of any kind
- Development of marketing/promotional resources such as a website for the municipality or county,
- iv. Planning studies/analysis for municipality/county use,
- v. Training or meeting facilitation for the city or county
- C. Grant funds <u>may not</u> be used to supplant regularly budgeted staff or project funds, to purchase rolling stock, furniture, fixtures, equipment, or normal operating expenses, etc.
- D. Documentation of cash expenditures must follow the Department of Local Affairs process including:



THREE WAY AGREEMENT

And

Town of Center, Center Community Park Playground Equipment Improvements

WHEREAS, the Colorado Department of Local Affairs, hereinafter DOLA, has contracted with the San Luis Valley COG, Hereinafter SLVCOG, to provide technical assistance in the counties of Alamosa, Conejos, Costilla, Mineral Rio Grande and Saguache and all municipalities within the member counties.

WHEREAS, the <u>Town of Center (Community)</u>, hereinafter the Community, has requested assistance through this program to assist in updating and replacing the playground equipment at the Center Community Park. This project will provide an updated and modern place for park activities; the improvement will also aid in safe equipment and the health and well-being of the youth. <u>This is a small-scale capital improvement</u>.

WHEREAS, the DOLA and SLVCOG desire to assist local governments and political subdivisions of the State that are experiencing social and economic impacts resulting from the development of energy/mineral resource industries in Colorado, and

WHEREAS, it is necessary and desirable to specify these services, the desired end product and the responsibilities of DOLA, the COG and the Community in completing this mini-grant project.

Now, THEREFORE, it is hereby agreed that:

SCOPE OF PROJECT

SLVCOG shall provide the services to the community as detailed in Attachment A, Scope of Services entitled "Community Services" Dated <u>5/09/2023.</u>

II. COST ESTIMATE

Employees of the SLVCOG will review documentation submitted by the Community and prepare the reimbursement. The SLVCOG will be responsible for completing reporting and reimbursement requests to DOLA, per contract #: EIAF 9550.

VI. COMMUNITY RESPONSIBILITIES

The Community will be responsible for entering into the agreement with the service provider to complete the work. The Community will provide all necessary documentation to the SLVCOG, including invoices for work completed, proof of payment and project completion report.

VII. PERIOD OF PERFORMANCE

ATTACHMENT A SCOPE OF SERVICES

1. PROJECT DESCRIPTION, OBJECTIVES AND REQUIREMENTS

The Town of Center has planned to update and replace the playground equipment at the Center Community Park. The improvements will offer a park with modern activities as well promoting the health and well-being of youth. The requirements for the replacement and the update of the current playground equipment include all labor and material that is needed to install the improvements.

2. TIME OF PERFORMANCE

The Project shall commence upon the Effective Date and shall be completed on or before December 31, 2023.

Performance of this Contract shall commence as soon as practicable after the Effective Date of this Contract; provided however, that the Community shall not be entitled to payment for any performance rendered before the Effective Date and shall not be eligible for reimbursement of any expenses incurred before the Effective Date. The Community shall undertake and perform its obligations hereunder as set forth in Attachment A. The Community agrees that time is of the essence in the performance of its obligations under this Contract.

5. PAYMENT PROCEDURE

The SLVCOG has established billing procedures and will pay the local government for actual expenditures made in the performance of this Contract based on the submission of SLVCOG documents in the format prescribed by the SLVCOG. The Community shall submit requests for reimbursement, setting forth a detailed description of the amounts and types of reimbursable expenses.

Payments pursuant to this Contract shall be made, in whole or in part, from available funds encumbered for the purposes of this Contract. The liability of the SLVCOG, at any time, for such payments shall be limited to the amount remaining of such encumbered funds. In the event this Contract is terminated, final payment to the Community may be withheld at the discretion of the SLVCOG until completion of final audit. Incorrect payments to the Community due to omission, error, fraud, or defalcation shall be recovered from the Community by deduction from subsequent payment under this Contract or other contracts between the SLVCOG and the Community, or by the SLVCOG as a debt due to the SLVCOG. Funds will be recompensed at the lesser of either the stated percentage match by the project OR actual documented reimbursement requested.

6. CONTRACT MONITORING

The SLVCOG shall monitor this Contract on an as-needed basis, as determined by the SLVCOG in its sole discretion. The SLVCOG or any of its duly authorized representatives shall have the right to enter, inspect and examine the Project upon twenty-four (24) hours advance written notice to the Responsible Administrator.

7. REPORTING SCHEDULE

At the time the Community submits quarterly payment requests, the Community shall submit, on a quarterly basis, financial and narrative status reports detailing Project progress and properly documenting all to-date expenditures of SLVCOG Mini Grant funds. The form and substance of such status reports shall be in accordance with the procedures developed and prescribed by the SLVCOG. The preparation of reports in a timely manner shall be the responsibility of the Community and failure to comply may result in the delay of payment of funds and/or termination of this Contract.

8. CONTRACT TERMINATION

This Contract may be terminated as follows:

a) Termination Due to Loss of Funding. The Parties hereto expressly recognize that the Community is to be paid or reimbursed with funds provided to the SLVCOG for the purposes set forth herein, and therefore, the Community expressly understands and agrees that all its rights, demands and claims to payment or reimbursement arising under this Contract are

contingent upon receipt of such funds by the SLVCOG. In the event that such funds or any part thereof are not received by the SLVCOG, the SLVCOG may immediately terminate or amend this Contract.

- b) Termination for Cause. If, for any reason, the Community shall fail to fulfill in a timely and proper manner its obligations under this Contract, or if the Community shall violate any of the covenants, agreements, or stipulations of this Contract, the SLVCOG shall give written notice to the Community of such delay or non-performance. If the Community fails to promptly correct such delay or non-performance within the time specified in the notice or twenty (20) days from the date of such notice, whichever is greater, the SLVCOG shall have the right, at its sole option, to terminate this entire Contract, or such part of this Contract as to which there has been delay or failure to properly perform, for cause. If the SLVCOG terminates this Contract for cause, the SLVCOG shall reimburse the Contractor for only eligible expenditures made up to the date of termination. Notwithstanding the above, the Community shall remain liable to the SLVCOG for any damages sustained by the SLVCOG by virtue of any breach of this Contract by the Community, and the SLVCOG may withhold any payments to the Community for the purpose of offset until such time as the exact amount of damages due the SLVCOG from the Community is determined.
- c) Termination for Convenience. When the interests of the SLVCOG so require, the SLVCOG may terminate this Contract in whole or in part for the convenience of the SLVCOG. The SLVCOG shall give written notice of termination to the Community specifying the termination of all or a part of this Contract and the effective date thereof, at least twenty (20) days before the date of termination. Exercise by the SLVCOG of this termination for convenience provision shall not be deemed a breach of contract by the SLVCOG. Upon receipt of written notice, the Community shall incur no further obligations in connection with the terminated work and, on the date set in the notice of termination, the Community shall stop work to the extent specified. The Community also shall terminate outstanding orders and subcontracts as they relate to the terminated work.

THE TOWN OF CENTER IS PARTNERING WITH CENTER VIKING YOUTH CLUB TO DEVELOP MULTIPLE STUDENT RUN BUSINESSES THROUGH A GREEN BIZ INCUBATOR. CENTER VIKING YOUTH CLUB WILL INVOICE THE TOWN OF CENTER'S DOLA REDI GRANT FOR UP TO \$20,000 TO PROVIDE RELEVANT WORKSHOPS AND DEVELOP A VISION FOR THE GREENHOUSE SPACE WHICH IS THE LAUNCHPAD FOR MULTIPLE STUDENT BUSINESSES.

The Green Biz Incubator/ Cooperative will launch 5-7 student run business plus teach multiple workforce skills as a result of building a greenhouse attached to Center Viking Youth Club. The growing space will be divided based on differing business needs and sales cycles. On average at least 50% of the space will be devoted to greenhouse related businesses not involving STEM education although this will vary with time of year and level of business activity. It will be run as a cooperative with a portion of each smaller business's profits being returned to the Green Biz Cooperative to maintain the space and launch new start up ideas.

Sales of various products and services will occur directly through Greenhouse space, Center Viking Boys and Girls Club plus the Blue Loft teen space. The students are also exploring how to link sales with various school fundraisers and this will be part of the larger business model they are working on this summer.

The following start-up business ideas are at various stages of development; additional ideas are likely to emerge once the Green Biz Incubator is more fully established.

- HempBuild Crew: One graduating Senior plus several other students want to start a hemp/build company. Hempcrete construction is ideal for greenhouses because of the high insulation value and how they moderate humidity. This greenhouse would become a demo for selling smaller home based greenhouses that also provide home energy benefits for reduced heating. Hemp material is also ideal for accessing affordable housing funds based on owner/ build models. It's easy to learn and that's a key strategy they plan to use. Rocky Mountain Hemp Builders will offer a workshop and at least 4 students will learn how to build with this material as they construct the greenhouse. They will also gain construction and business skills relevant to greenhouse construction and this building would serve as a demo.
- Center Spice Company: Last year a student launched a small spice company and successfully sold his product. He was growing spices in the yard of his family home but found he could not grow enough and obviously not at all in the winter, so he gave up. We hope to find a new students willing to take his original work to a next level. They would use a section of the greenhouse to grow the product.
- Smarty Plants: This is flower business that will initial focus on 4 seasonal sales periods: Christmas, Valentine's Day, Mother's Day, Graduation. They will grow and market the type of flowers most relevant to each occasion.

- Marlo Tree Planting will include tree planting workshop and they are considering the long term
 possibility of a tree planting nursery and related arborist services.
- Organic Lotions Enterprise: Several students want to launch this business and will be learning
 how to mix the product and create their business late May early June. They will likely use a
 small amount of greenhouse space for Aloe and related plant based additions to their lotions
 formula.
- DreamBuilders Health/ STEM workshops: Dream Builder are a group of students who are interested in the education or psychology field. Next year they will design workshops and experiments specifically designed to teach health and science related topics to younger students. There are numerous small grants available to support this work. Last summer, several students did receive a grant for a social emotional workshops and have another grant submitted for this year. These students will focus on small grant applications for STEM and Health programs and use this space for their workshops and experiments.
- Vertical Garden Team: 6 students developed a vertical garden structure that local residents could place in their home. They may use this space to further test and showcase their product. This would likely focus on small grant applications.
