



The owners of 771 Wills St. are requesting a variance because the edge of the permanent canopy structure they intend to build sits on a fence with the adjacent property. Meaning, this structure encroaches on the setback. The canopy is to be placed over their existing concrete pad. It will have no permanent enclosures on the sides, meaning it will not become an enclosed space. They are seeking a variance to get approval to build this structure.

Additionally, they have a letter from the neighbor stating that they are okay with the structure. The property owner has also agreed to ensure that drainage flows into their property, not the neighbors. Lastly, they have agreed that they cannot enclose the property permanently at any time in the future.

Summary of Planning Commission Recommendation:

The Center Planning Commission recommended that this variance request be approved at their meeting on May 20th, 2024. This variance first came before the Planning Commission at their April 15th, meeting. However, after careful deliberation, the planning commission recommended that they get agreement that the structure will not be permanently enclosed at any time, as well as recommended that the code enforcer verify the letter of consent from the neighbor. Both steps were taken successfully and the property owner came back before the commission at the May 20th meeting, where this variance was recommended for approval with the condition that no permanent enclosed sides be added at any point in the future.

Code Enforcer's Note: Variance Request at 771 Wills St. (Della Duran)

Follow Up Notes for 5/20/2024 Planning Commission Meeting:

Per the request of the planning commission, the code enforcer has followed up on the recommendations of the commission who tabled this variance request at the last meeting. First, the code enforcer received verbal confirmation from the neighbor that the proposed is okay and that they did write and sign the letter. Second, we received confirmation from the property owner that they approve of the requirement that they will not enclose or add permanent siding to the canopy. Third, we discussed the drainage and confirmed that it would drain onto the owners property, not the neighbors.

Review of the Town of Center's Organizational Structure:

INTRODUCTION

At this week's Town Council meeting, the trustees will review the current organizational structure of the Town of Center. We will discuss what this means for the powers of the individual trustees, the town administrator, and the staff. Additionally, we'll talk about how this organizational structure came to be and attempt to answer other questions relevant to the board and the public.

ORGANIZATIONAL STRUCTURE OF THE TOWN OF CENTER

I. Summary of Organizational Structure

The Town of Center is a statutory town. The elected Town Board and Mayor are the chief legislative and policy-making body of the Town. The Town Administrator, appointed by the Town Board, is the chief executive officer of the Town and is responsible for proper administration of the Town government in accordance with its policies, including the proper management of all employees. The Town Manager may delegate to Department Heads authority for administration most properly carried out at the departmental level.

II. More Detailed Breakdown of Organizational Structure

The following information is drawn and quoted from the *Town of Center Personnel Policies and Procedures Manual*, adopted September 6th, 2011 by the Center Board of Trustees.

Statutory Town: The Town of Center is a statutory town operating in accordance with Colorado Law (C.R.S. 31-4-301).

The Town Board: The Town Board is composed of six elected members and an elected Mayor, which is the legislative and policy-making branch of the Town government. They are the ultimate policy making authority for the Town of Center...The Town Board shall be responsible for the appointment of the Town Manager, Town Attorney, Chief of Police, Town Clerk, and Municipal Judge. (TOC Personnel Policies and Procedures Manual)

The Town Manager: The Town Manager is the administrative officer for the Town and responsible for the operation and management of all departments in accordance with the organizational structure. The Town Manager is appointed by the Town Board, is the Chief Executive of the Town, and is responsible for the proper administration of the Town government,

including the right to exercise all authority delegated within this policy. (TOC Personnel Policies and Procedures Manual)

Town Organizational Structure: The Town has a defined organizational structure which identifies all departments and associated working relationships. The Town Manager and Department Heads shall be responsible for the management of all employees and for providing a safe and productive work environment for all employees. All employees must understand the overall organization structure and the required chain of command associated with every position. All employees and their job output and personal contributions are essential for the efficient and effective operation of the Town. Proper training, effective planning and scheduling, execution of daily tasks and positive morale by all employees will lead to overall job satisfaction and recognition of a job well done. All employees contribute to organizational progress and overall work output and in order to maximize these gains it is essential that the organizational structure is understood and followed by all Town employees. (TOC Personnel Policies and Procedures Manual)

The following is a summary of relevant ordinances related to the existing organizational structure and management of the Town of Center

Summary of Ordinance No. 417 - Adopted by the Center Board of Trustees on September, 6th 2011

Title: An Ordinance Adopting an Organizational Chart and Establishing Appointments, Roles and Responsibilities for the Town Attorney, Town Clerk/Treasurer and Town Manager for the Town of Center, Colorado

This ordinance spells out the organizational chart and establishes the appointments, roles, and responsibilities for Town Attorney, Town Clerk/Treasurer, and Town Manager. It aligns with the Personnel Policies outlined above.

Additionally, it specifies a drawn organizational chart and provides a job description for the Town Manager. Its description states, "The Town Manager is appointed by the Town Board and serves the Town Board in accordance with the roles and responsibilities detailed in the job description" (Ordinance No. 417). This job description outlines that the Town Manager is "responsible for the enforcement of the laws and ordinances of the Town" and to "appoint, suspend, discipline, and remove all employees of the Town except for the Town Clerk and Town Attorney, subject to adopted personnel rules and regulations of the Town" and to "make appointments on the basis of executive and administrative ability and the training and experience of such appointees in the work which they are to perform", among several additional duties and responsibilities (Ordinance No. 417).

Summary of Ordinance No. 441 - Adopted by the Center Board of Trustees on December 4th, 2012

Title: An Ordinance Amending Ordinance No. 417 (An Ordinance Adopting an Organizational Chart and Establishing Appointments, Roles and Responsibilities for the Town Attorney, Town Clerk/Treasurer and Town Manager for the Town of Center, Colorado)

In 2012, this ordinance was made as an amendment to Ordinance No. 417. The Town Board of Trustees felt that there should be additional regulations for the Town Manager regarding the approval of employee wage increases. To summarize, this ordinance ensures that the Town Manager prepares a schedule of employee wage increases for review and approval by the Town Board prior to the annual employee review process. This was done due to a desire of the Board of Trustees for stricter review of wage increases for town employees.

WHAT DOES THIS MEAN FOR BOARD MEMBERS?

The Town of Center Board of Trustees creates and adopts the policies that the Town Manager and employees carry out. For instance, the Town Board could commission a revision of our personnel policy and the allocation of responsibilities of the Town Administrator. However, due to our currently adopted policy, that means the Town Board has very limited involvement in the administration and management of personnel beyond the Town Manager, Attorney, and Clerk.

CIRSA, the Colorado Intergovernmental Risk Sharing Agency, who is our insurance agency and protects municipalities and government agencies like ours, puts out a handbook on Ethics, Liability, and Best Practices for Elected Officials. Chapter 1 of their handbook discusses the Oath of Office for elected officials. They state how respecting the allocation of responsibilities that a board member has is part of an elected official's oath. Thus, inappropriate involvement in administrative matters could be a violation of the oath. This would be the case if elected officials became involved in personnel matters outside of their direct reports according to our policy. That could become a liability for the Town and open us up to lawsuits to our detriment.

When in doubt, the Town can contact our Town attorney or our designated attorney with CIRSA to get assurances and counsel regarding appropriate actions in accordance with our own policies and state laws.

CONCLUSION

The Town of Center's adopted mission statement is that "The Town of Center, Colorado shall provide strong leadership, inspire community pride, maintain fiscal accountability and through its employees offer a high level of service to the residents, businesses, and visitors of the community." The Town does this by functioning in accordance with state laws and the policies created and adopted by the elected Town Council. The Town's employees are then charged with carrying out and ensuring compliance with these laws and policies, with a summarized goal of serving our community of Center.
