APPROVAL OF AGENDA

A motion to approve the agenda was made by Trustee Barela, seconded by Trustee Duran. Roll Call –All in favor. Motion Carries.

CITIZEN COMMENTS

<u>Leonard Garcia</u> — When the water meters that were installed his water worked well, after a while there was no pressure. Mr. Garcia still has dirt and low pressure; the utility crew blew it out. It has been an ongoing issue. Dave advised that he should call somebody to check his side. Mr. Garcia did take someone to check it out and they did but the boiler had dirt. The bill was turned over to Dave and nothing has been done. He got late charges since it wasn't paid. Mr. Garcia asked that they check into the issue and the bill also.

CONSENT AGENDA

Minutes - No questions were asked.

Court Report – The Board said it was nice to see the tickets being paid.

<u>Police Report</u> – Chief Fresquez asked if there were any questions, they did have a lot of tickets issued. Mayor Garcia asked how the training at the school went. Chief Fresquez said it went well, they will continue to train there. Designated Teachers would become crossing guards if anything serious were to happen as the officers would be dealing with the major issue. They will be doing more training; Officer Martinez has been in the school learning what needs to be done. Officer Martinez will leave to the academy in June and be ready once he completes the academy. Officer Martinez will have a K-9 dog while the school season is in session. The Center Drags was a great success they did not make as much money but they didn't have the food sales.

Public Works Dept. Reports - Manuel Tafoya represented the Utility Department.

<u>Utilities</u> – Mayor Pro-Tem said that they are moving right along with the new electrical upgrade.

The rectifier for the gas system is running good. The dry air impacts the rectifier.

Water - No questions were asked.

Streets and Parks – No questions were asked.

Building Report - No questions were asked.

A motion to approve the consent agenda was made by Trustee Gallegos, seconded by Trustee Barela. Roll Call –All in favor. Motion Carries.

A motion to approve the payables was made by Trustee Barela, seconded by Trustee Gonzales. Roll Call – All in favor. Motion Carries.

MANAGER'S REPORT

<u>Water Information Campaign</u> — Brian met with Citizen Mitch Garcia and had a productive meeting to discuss issues he has brought to the Board's attention. They talked about getting an informational campaign about the water and the health of compromised individuals. They will try working with Valleywide and AHEC to help with this project. Mitch said that there are still no results from the back-flow and would like more information about that issue.

<u>Infrastructure Grant</u> – The Town had applied for a 10 million dollar grants. There were a lot of applicants but the Town did not receive the grant. Brian will have an outbreak meeting with the group to find more funding for the projects that need to be done. The Goal is to have ground breaking with affordable housing but money dictates everything.

<u>ARPA Funds for Businesses for Refurbish Buildings</u> – The American rescue plan money was received. They can have given to businesses in a form of a grant to assist them to refurbish there building. Littleton has a pilot program; Brian has reached out to them. May 2nd Brian attended SLV roadmap meeting and they told Brian that the MSOB grant was the best written grant and it scored the highest. Mitch asked about a report to the Board about the money they received. Brian will be looking at and how to spend the money with their guidelines.

NEW BUSINESS

<u>Establishing the Urban Renewal Authority</u> – The public hearing was held for the community. We had a good turnout. No increase taxes and no risk to the Town. There will be three additional spots on the Board from the School, the County and a Special District. Brian read the resolution 050923 out loud concerning the Center Urban Renewal Authority. A motion to approve resolution 05092023 was made by Mayor Pro-Tem Martinez, seconded by Trustee Gallegos. Roll Call – All in favor. Motion Carries. A motion to establish the Urban Renewal Authority was made by Mayor Pro-Tem Martinez, seconded by Trustee Gonzales. Roll Call – All in favor. Motion Carries.

<u>Parking/Painting the line on Main St.</u> – Brian is still waiting on the costs for doing the Parking/painting of the lines on Main St.

<u>Town Manager Contract</u> – Mayor Garcia said that he feels with all the work that Brian has done he would like to meet with the attorney to make a contract. The Mayor feels that he would like Brian to

complete projects and would like to offer a contract so that he is not tempted to leave the Town. Mayor Pro-Tem Martinez said that they need to work with the attorney on a contract. A two-year contract is standard. Mitch asked the Board how the evaluate Brian. Mitch feels that they should do their homework. There is a liability with a contract instead of at will employee. A motion to have Attorney Trujillo work on a contract with Brian was made by Trustee Gallegos, seconded by Trustee Barela.

K-9 Kennels -

Chief Fresquez said that he has some grant money to purchase the kennels out of cinder blocks. Chief Fresquez said that he has donations for the project. 900+ cement, 3800 to put in drains in. Chief is asking for approval from the Board for this project. The cost is about seven to eight thousand. It will cost about three thousand from budget. Chief Fresquez talked about the success of his K9 program. A motion to approve the building of the kennels was made by Trustee Barela, seconded by Trustee Gallegos. Roll Call — all in favor. Motion Carries.

OLD BUSINESS

Mitch Garcia - Discussion on Drug Use -

Mona Garcia was speaking on behalf of Mitch and said that we have to inform the community about what's going on. There were many issues to address in Center. Mona read comments from Mitch. Mayor Pro-Tem Martinez said that she was working very close with the drug programs. The program pulled out of Center because the Police patrol the streets so the users felt like they couldn't get help. Mayor Pro-Tem said that she is going to continue to work through the program. The Town does have the Lead program that Chief Meek established.

A motion to approve the agenda was made by Trustee Gallegos, seconded by Trustee Barela. Roll Call – All in favor. Motion Carries.

CITIZEN COMMENTS

James Sanchez – Mr. Sanchez had a concern about shots fired on Garcia St. Mr. Sanchez called into dispatch but did not hear back from them. Mr. Sanchez would appreciate a call back to make sure they are safe.

Mitch Garcia — Mona spoke for Mitch. Mona read I'm down but not out. Spoke about Brian and his duties. Talked about the seventies and being oppressed by a white Board, now there is a Latino community being oppressed by a Latino board. Mr. Garcia sent a letter to Governor Polis. Mr. Garcia said he will not compromise Police for wasteful spending. Chief Fresquez is the only one that responds concerning community concerns. Mr. Garcia said he will continue ask for Brian's removal.

Ken Dalby – Mr. Dalby wanted to talk about the water pressure. Mr. Dalby's mom is having major water spikes. Mr. Dalby had two years of spike reports. Mr. Dalby believes that it is the water valves. There has been a 30% reduction in volume. The significant change for delivery was when the Water Tower moved. Mr. Dalby is recommending replacing a few meters with a bigger size. Rose will distribute the reports.

Bill McClure- Mr. McClure said that his vehicle was stolen and has pictures of the suspects. Mr. McClure said that he kept bringing up the issues with the police. The Chief has not spoken to Mr. McClure about this issue. The police are more interested in training dogs then working on the crime. Mr. McClure would like the Board to do something about the Chief. The Town Manager allowed the Town to have a vendor park on businesses parking. Brian told him he was against the Town which he says he is not. Mr. McClure asked if they will allow out of Town vendors to park on public streets.

FINANCIALS

A motion to approve the Financial Statements was made by Mayor Pro-Tem Martinez, seconded by Trustee Duran. Roll Call –all in favor. Motion Carries.

PAYABLES

A motion to approve the payables was made by Trustee Barela, seconded by Trustee Gallegos. Roll Call —all in favor. Motion Carries.

NEW BUSINESS

Energy Rate – Charging Station – A motion to approve the rate of .25 per kwh was made by Mayor Pro-Tem Martinez, seconded by Trustee Duran. Roll Call – All in favor. Motion Carries.

Mini Grant Approval – The grant is from the council of governments for up to \$5,000. The cost is \$13,000 minus the \$5,000. The rest of the money will come from DOLA. It will be a reimbursement grant. It is a 3 way contract. The Board had the pictures in the packet. A motion to approve the project in the amount of \$13,880.15 with \$5,000 being reimbursed and three-way agreement was made by Trustee Gallegos, seconded by Trustee Barela. Roll Call – All in favor. Motion Carries.

REDI Grant Youth Agreement — Youth enterprise zone for continuing using the REDI grant. DOLA is requiring the Town to enter an agreement with the Center Youth program. The students are using the Green House currently, Brian explained what they are growing. The goal is to eventually use the green house and teach them how to run a business. DOLA is not comfortable without the Town being in charge of the project. Mr. McClure asked why the school is not doing this, why is the Town? A motion to approve the REDI Grant was made by Trustee Barela, seconded by Trustee Gallegos. Roll Call —All in favor. Motion Carries.

OLD BUSINESS

Leonard Garcia — Brian talked about Mr. Garcia and the issue he had at the last meeting. Dave had researched the warranty. The Town did talk to Leonard concerning what they plan to do. A motion to reimburse Leonard Garcia was made by Trustee Duran, seconded by Trustee Beiriger. Roll Call —All in favor.

WATER AND SANITATION DEPARTMENT MAY 2023 REPORT

5/3/2023

WATER OVERVIEW

1. Drinking Water Monitoring Schedule

We are continuing this year's monitoring schedule and results are still meeting requirements.

2. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system with some variation at entry point. We changed the Cl2 barrel at the West and East Well.

3. Water Quality

We conducted water quality assurance calls to customers as directed and we did water turn on and offs as needed.

4. Projects

We continued to work on surveying for the backflow program. Pictures of backflows have been uploaded on Diamond Maps to also help us track the different devices and locations. We have sent out letters to commercial customers to inform them that water meters and backflow devices must be installed. We have drafted a letter to inform commercial customers with existing backflow devices that they must be inspected annually. We collected data at all of the commercial customers to get meter, backflows and MXU numbers. We are working on getting them to all read automatically. We are in the process of getting a new meter register for the preschool from Sensus. The register that's at that preschool is running low on battery. The Pit Stop Gas Station and Aspen's water was turned off because they are refusing to install a water meter and back flow device. Aspen has purchased water meters as well as back flow devices from the Town and they are working on getting them installed.

5. Water Tank

We have completed the Water Tank inspection for the month. The Water Tank is in good condition. We accepted a bid for the comprehensive water tower inspection and are waiting to be scheduled.

6. Other Tasks

We were approved by the State on the alternate Backflow compliance plan. We are trying to get Tim from Sensus to come down and help get the commercial meters are communicating and reading. We are trying to get a few home owners to stop tampering with the water pits and water meters. We are trying to get more backflows, meters and MXU. We are trying to get all the commercial buildings to install meters and backflows.

SANITATION OVERVIEW

1. Process Control Monitoring

We continue to run daily process control tests. There's nothing to report as all the numbers have been good.

2. Lift Station Checks

Daily lift station checks have been completed. All the lift stations are running with two pumps.

3. Sewer Obstructions

We have had several calls this last month on sewer issues and backups.

4. Jetter Truck

The jetter truck had been out to Bid, USDA requires 30 days for the bidding process so the Engineers will start opening the bids on May 17th. We received 1 bid on a vactor truck. We are now waiting for final approval from USDA.

5. Sampling and DMR's

All the numbers continue to be with in parameters. DMR's have been submitted and we are in compliance. We are running all but two tests in house now.

6. Plant Operations

We continue to learn and become better at troubleshooting issues. We had an issue in the headwork's with the band screen that took several days to clean up and troubleshoot; however, we were able to fix it and get the room cleaned. We did have some warranty work on the concrete in the basins completed.

7. Other Tasks

Updating policies has been an ongoing project. We are also looking into different avenues to get the collection system inspected. I have received two quotes on inspecting the mains and am waiting for the third one currently. We are getting quotes on building an office space inside the treatment plant, mainly for more electric capability and for a sound barrier. We are also getting quotes on laying a concrete slab under the bio solids rollaway dumpster as the weight in the dumpster causes it to sink.
