Town of Center Public Works Department.

Report for: September, 2024

Overview

The Public Works Department, which includes the Street and Parks Department, Utility Department, Water/Sanitation Department, and Code Enforcement, has made significant progress in ongoing projects and community services this month. The team has worked diligently to improve infrastructure, ensure public safety, and enhance community spaces. Below is a breakdown of key updates and achievements for the month.

Street and Parks Department

Community Playground Demolition:

In preparation for the installation of new playground equipment, the demolition of the existing community playground began on September 26th. This is an exciting upgrade that will provide improved recreational facilities for our residents. The new equipment is expected to be safer and more accessible for children of all ages, with the project completion targeted for mid to late October.

· Paving of Potholes on Broadway and Hwy 112:

Our street maintenance team has been busy addressing numerous potholes along Broadway and Highway 112. The work has improved driving conditions and will continue to be a priority as we monitor other areas in need of similar repairs. We appreciate the community's patience during these repairs.

• Equipment Upgrade Suggestions:

It is my understanding that Trustee Sanchez stopped by the site and suggested that the Street and Parks Department may consider acquiring better equipment to streamline maintenance work. This includes upgrading to more efficient mowers and new snow removal tools. These recommendations will be evaluated during the next budget cycle to ensure we continue providing excellent service while staying within financial constraints.

Stop Signs:

I have received several complaints about the stop signs around town, particularly at the intersection of Hurt and 2nd St., where some residents have raised concerns. Additionally, there have been requests from citizens to install new stop signs at the intersections of 3rd St. and Jones, as well as Wills and 7th St. Since the decision to install or remove stop signs fall under the authority of the Board, I would like to know how the Board would like to proceed with these matters. Your guidance on how best to address these requests will be appreciated.

Utility Department

Electrical Power Outage:

On the night of September 20th, the town experienced a significant power outage that affected many residents. The outage continued through most of Saturday afternoon and was caused by Inclement weather. Our team worked around the clock to restore power, and we have since implemented measures to prevent future occurrences. We apologize for the inconvenience this caused and are committed to improving our infrastructure for greater reliability.

• Electrical Pole Upgrades:

This month, we began the long-awaited upgrade of electrical poles, focusing on the areas west of Center near Casa de Cortez and on Central Avenue. These upgrades will improve electrical reliability and reduce the risk of outages, especially during inclement weather. We expect this project to be completed within the next few weeks.

The utility crew continues to make steady progress on the underground project, ensuring
improved infrastructure for the town. In addition to this, they are also replacing several
streetlights that have gone out in various areas, enhancing visibility and safety for
residents. Their hard work and commitment to these improvements are greatly
appreciated.

Water and Sanitation Department

· Routine Maintenance and Upgrades:

The Water and Sanitation Department has been conducting regular maintenance of water lines and sewage systems to ensure consistent service. We are also planning to initiate several upgrades to aging pipelines, which will improve water quality and pressure throughout the town. In addition, we are exploring ways to improve wastewater treatment to ensure compliance with environmental standards.

Sewer Obstructions:

We have had several calls this last month on sewer issues and backups. We will start to see a decrease in calls as we, thoroughly go through, and clean the system. A sewer main that runs through the side of an agriculture settling pond collapsed. The agriculture contractor repaired the line under our supervision. This event brought up questions regarding the legality of having unlined settling ponds.

Code Enforcement Department

• Community Clean-Up and Compliance:

The Code Enforcement team has been actively working to address community concerns regarding property upkeep and sanitation. Several notices have been issued for neglected properties, and we are seeing positive responses from homeowners in terms of compliance. We continue to encourage residents to maintain their properties, particularly as we head into the fall season when yard maintenance becomes critical.

Looking Ahead:

The upcoming month will see the installation of new playground equipment, continued upgrades to our electrical infrastructure, and ongoing road maintenance projects. We will keep the community informed of any disruptions and appreciate everyone's cooperation as we work to improve our town's infrastructure and services.

WATER AND SANITATION DEPARTMENT SEPTEMBER 2024 REPORT

10/3/2024

WATER OVERVIEW

1. Drinking Water Monitoring Schedule

We are continuing this year's monitoring schedule and the results are still meeting requirements.

2. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system. We changed the Cl2 barrel at the West and East Well.

3. Water Quality

We conducted water quality assurance calls to customers as directed and we did water turn on and offs as needed.

Projects

We have continued to work on our compliance with the backflow prevention installation and testing. The engineering firm that has been assisting systems throughout the State has completed the Lead and Copper Inventory. Before we can submit the Inventory to the State, we have to verify a discrepancy of approximately 100 service connections. The Lead and Copper Inventory will be an ongoing project. The Fire Hydrant Inspections is still an ongoing project.

5. Water Tank

We have completed the Water Tank inspection for the month and had Rubicon complete the annual compressive Tank Inspection.

6. Other Tasks

Backflow compliance for commercial water meters continues to be ongoing projects. We are hand delivering 60-day reminder to commercial water users that have tested. We are checking high usage to let customers know for passible leaks. We are really pushing to have all customers compliant with water meters and backflows. We helped the Utilities crew with the major power pole incident. Follow-ups on high water usage has been conducted to help eliminate possible leaks. We have been working on the commercial and residential meters that are not reading automatically.

SANITATION OVERVIEW

1. Process Control Monitoring

We continue to run daily process control tests. As the temperatures outside are cooling down we are starting to monitor the MLSS more closely.

2. Lift Station Checks

Daily lift station checks have been completed. Now that we have the Vactor truck, we are scheduling to clean thoroughly each lift station. We have cleaned out the Park Lift Station.

3. Sewer Obstructions

We have several calls this last month on sewer issues and backups. We will start to see a decrease in calls as we, thoroughly go through, and clean the system. A sewer main that runs through the side of on agriculture's settling pond collapsed. The agricultures contractor repaired the line under our supervision. This event brought up questions regarding the legality of having unlined settling ponds.

4. Jetter Truck

We have started to clean the collection lines. We were delayed by the problem of where to dump the vactor. We created a temporary solution over a manhole by the waste treatment plant. We plan on further cross training on the Truck by rotating a Utilities person to participate in the collection line cleaning until everyone is comfortable operating the equipment.

5. Sampling and DMR's

All sampling and lab work continue to be completed. All of our labs and DMRs have been compliant. We are achieving 98 to 99% removal of TSS (Total Suspended Solids) and BODs (Biochemical Oxygen Demand). We have been working on collecting samples from the "BOD" customers to get new and more accurate data for their rates.

6. Plant Operations

We got the blower motor back from Denver and it is now operational. We had one of the decant pumps went down. The pump is at the service shop undergoing diagnostics. We have had a few more issues with electrical equipment outside of the plant. We are working with the representatives for solutions.

7. Other Tasks

The apprentices have been working on assignments and trainings as well as completing their day-to-day duties.
