
# WHAT IS THE VALUE OF CENTER'S ASSETS?

Would you believe the Town of Center has nearly \$8 million in assets!? No kidding!

And what *IS* an asset, you ask? Our assets include the Town's property and systems. And Center has lots of assets: buildings, streets, sidewalks, our gas utility, electric utility, water utility, drainage system, parks, open space, the Consaul property, and other things. In the past, we've never had a full list—or inventory—of all our assets. But now we do.

An inventory of all Center's assets was just completed and presented to the Town Board at the October 13 meeting. It includes photographs of all assets, aerial photos of the town, detailed maps, and lists of all Town properties including their value, age, condition, location, cost of replacement, and years of expected use.

The cost to complete the inventory was \$90,000. Fortunately, the entire cost was paid by the Colorado Department of Local Affairs DOLA. No cost to the Town! How can we use this Asset Inventory? Why is it important?



It is a very useful management tool to us as individual residents, as well as to the Town. The part that can be useful to all of us residents is a collection of maps of each block in Center showing the location of houses, gas, water, and electric lines, power poles, street lights, fire hydrants, fences, isolation valves, and other features within that block. If you need to know specific details of

your property, you may come in to the Town Hall and ask to see these maps. They may help you in planning additions or repairs to your property.

The Town will use this information to show us what we need to plan and save for to keep our Town in good repair and to avoid serious breakdowns or disasters.

Our Asset Inventory reports that Center's assets are in overall average condition, considering that some of our systems were built in the 1960s. It makes recommendations for future improvements and expected costs of these improvements. It notes that Center is projected to grow from a population of 2,501 people in 2020 to 3,979 people in 2040. So we'll keep growing, improving, and beautifying for years to come.

## MUNICIPAL JUDGE HIRED

Barbara Zollars, who has served as interim judge for the past 3 months, was hired for the permanent position at the October 13 Town Board meeting. Judge Zollars is an attorney and is currently serving as municipal judge for Monte Vista. She is looking forward to standardiizing our court procedures as part of her job. Municipal Court will be held every third Wednesday at 5:30 pm at the Town Hall. Town Hall will be closed for other business at 5:00 pm on all court days.
