

## Town of Center Public Works Department.

Report for: October, 2024

#### Overview

The Public Works Department, which includes the Street and Parks Department, Utility Department, Water/Sanitation Department, and Code Enforcement, has made significant progress in ongoing projects and community services this month. The team has worked diligently to improve infrastructure, ensure public safety, and enhance community spaces. Below is a breakdown of key updates and achievements for the month.

#### **Street and Parks Department**

The new playground at the community park has officially been completed, marking a significant milestone for our neighborhood. It was a challenging three weeks for the Streets and Parks Department, particularly due to the complex task of re-routing the sprinkler water lines that ran directly through the playground area. Despite these obstacles, the team worked diligently to ensure the project was finished on schedule, and we are excited to provide a safe and engaging space for families to enjoy. The new playground, with its modern equipment and vibrant play areas, promises to be a wonderful addition to our community.

In addition to the playground work, crews have also started preparing for winter by winterizing the sprinkler systems in all parks, ensuring that our facilities remain in top condition during the colder months.

The Streets and Parks Department is currently preparing for winter by getting our snow plows ready for the upcoming season and winterizing our lawnmowers for storage. This proactive approach ensures that our equipment is in optimal condition when needed, allowing us to efficiently manage snowfall and maintain our parks. By taking these steps now, we can better serve the community throughout the winter months and ensure a smooth transition between seasons.

I wanted to follow up on the stop sign topic that I presented to the board last month. As this is a crucial safety issue for our community, I am eager to know if the board has reached a decision regarding the installation of the stop sign.

Stop signs in question to be removed- the intersection of Hurt and 2nd St. Additionally, there have been requests from citizens to install new stop signs at the intersections of 3rd St. and Jones, as well as Wills and 7th St.

New "NO PARKING" signs have been installed along Highway 112 to improve traffic flow and enhance safety in the area. These signs were put in place to address ongoing concerns about congestion and visibility, particularly during peak travel times. By prohibiting parking in these designated areas, we aim to ensure a clearer pathway for vehicles and reduce potential hazards

for pedestrians. We appreciate the community's understanding and cooperation as we implement these changes for the betterment of our roads.

#### Utility Department (Electrci and Gas)

The Utilities Department is pleased to announce that Phase 1 of the electrical pole upgrades has been completed. We are currently awaiting the arrival of a few ordered items needed to finalize the project. In addition, new streetlights have been ordered, and several have already been replaced, enhancing visibility and safety throughout our community. Our crew is diligently working to replace the remaining lights, ensuring that all areas are well-lit and accessible. We appreciate the community's patience as we continue to improve our electrical infrastructure.

As of now, the utility supervisor is maintaining open communication with Habitat (which was refered by Black Hills) to obtain a quote for the removal of the Mercaptan holding tank at the Border Station. We have been informed that the tank needs to be vac'd in order to provide a more accurate estimate for the removal process. This collaboration aims to ensure a safe and efficient removal while keeping costs transparent and manageable. We will keep the community updated on any developments regarding this project.

I have been working on adjustments to the electricity rates in light of the new contract set to take effect on April 1st, 2025. The board of trustees accepted this contract on August 13th, 2024, which marks a significant change for the Town of Center. Previously, we were purchasing power from NMPP or MEAN at approximately \$45/MWH, but under the new contract, that rate will increase to about \$56/MWH. This necessitates a rate increase for our residents; however, I believe the board made a prudent decision. If the Town of Center had opted to remain on the Schedule J or short-term contract, we would have faced costs of around \$72.50/MWH, increasing to \$76.20/MWH by the end of 2030. This new contract positions us more favorably in the long term.

Regarding gas prices, the last increase occurred in June 2024, when we raised rates by \$0.02 per cubic foot. We are continuing to closely monitor market prices, which have recently averaged around \$2.70 per cubic foot. This vigilance allows us to respond promptly to any fluctuations, ensuring that we remain aligned with market trends while striving to keep costs manageable for our residents. We will keep the community informed of any future changes as we assess the ongoing market conditions.

#### Water and Sanitation Department

The water department works diligently to manage the supply, treatment, and distribution of potable water to residents, businesses, and industries. The water department ensures that water meets health and safety standards by treating it to remove contaminants and overseeing the maintenance of water infrastructure such as pipes, pumps, and reservoirs. In addition to delivering clean water, the department may also manage wastewater treatment systems, stormwater management, and water conservation initiatives. The goal of a water department is to provide reliable, clean water services while maintaining sustainable practices for the long-term benefit of the community and environment.

The Fire Hydrant Inspections were complete. We have continued to work on our compliance with the backflow prevention installation and testing.

We submitted the completed Lead and Copper Inventory to the State. The Lead and Copper Inventory will continue to be an ongoing project. After review, we have identified your system has at least one line that is classified as lead, galvanized requiring replacement, or unknown. A list of affected systems is attached.

#### As a result, we are required to:

- Distribute a consumer notification of service line material to the specific customers with lead, galvanized requiring replacement, or unknown service line by hard copy delivery (mail, hand delivery, or posting for NTNCs) by November 15, 2024.
- Submit one copy of a representative notice and <u>certificate of delivery</u> by July 1, 2025.
- Repeat notice to the customer annually until you classify their service line material as non-lead and submit certification annually by July 1 each year.

#### **Code Enforcement Department**

The Code Enforcement team has been actively working to address community concerns regarding property upkeep and sanitation. Several notices have been issued for neglected properties, and we are seeing positive responses from homeowners in terms of compliance. We continue to encourage residents to maintain their properties, particularly as we head into the fall season when yard maintenance becomes critical.

#### Looking Ahead:

As we are getting to the end of the year, and beginning the new year, we are excited to move forward with the Worth and 3rd Street project, a critical initiative that will enhance the heart of our community. This project aims to revitalize one of our most traveled intersections, improving traffic flow, pedestrian safety, and overall aesthetics. Additionally, we are focused on completing several unfinished projects at Community Park, including upgrades to the playground and walking paths, which will provide a better recreational space for all residents. In parallel, we remain committed to strengthening the infrastructure of the Town of Center, working on improving roads, utilities, and public services to support the growing needs of our community. These efforts are essential to ensure a sustainable, thriving environment for years to come, and we look forward to seeing these projects come to fruition as we move into the new year.

#### WATER OVERVIEW

#### 1. Drinking Water Monitoring Schedule

We are continuing this year's monitoring schedule and the results are still meeting requirements.

#### 2. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system. We changed the Cl2 barrel at the West and East Well.

#### 3. Water Quality

We conducted water quality assurance calls to customers as directed and we did water turn on and offs as needed.

#### 4. Projects

We have continued to work on our compliance with the backflow prevention installation and testing. We submitted the completed Lead and Copper Inventory to the State. The Lead and Copper Inventory will continue to be an ongoing project. The Fire Hydrant Inspections were complete. We now have to send out notices to all of the addresses that are known to contain lead, galvanized metal or are unknown materials.

#### 5. Water Tank

We have completed the Water Tank inspection for the month and had Rubicon complete the annual compressive Tank Inspection.

#### 6. Other Tasks

We are checking high usage to let customers know for passible leaks. We are really pushing to have all customers compliant with water meters and backflows. Residential meters are being worked on for invalid reads as well as zero reads. We have been working on the commercial and residential meters that are not reading automatically.

#### SANITATION OVERVIEW

#### 1. Process Control Monitoring

We continue to run daily process control tests. As the temperatures outside are cooling down we are starting to monitor the MLSS more closely. We haven't had to cut back on wasting yet.

#### 2. Lift Station Checks

Daily lift station checks have been completed. We have cleaned out the Park Lift Station and Jones Oil Lift Station.

We are planning to clean out the School Lift Station soon.

#### 3. Sewer Obstructions

We have several calls this last month on sewer issues and backups. We have addressed the sewer calls as they arise.

#### 4. Jetter Truck

We are still planning on cross training on the Truck by rotating a Utilities person to participate in the collection line cleaning until everyone is comfortable operating the equipment. This is becoming more challenging as the weather is cooling off.

#### 5. Sampling and DMR's

Sampling and testing has been completed with out any issues.

#### 6. Plant Operations

The decant pumps that went down is in Denver being rebuilt. We have had a few more issues with electrical equipment outside of the plant. We are working with the representatives for solutions.

#### 7. Other Tasks

The apprentices have been working on assignments and trainings as well as completing their day-to-day duties.

- I went to speak to the panorosa partnership potatoes about the blight they had on 5<sup>th</sup> and Cisneros St they did advise me that they would get it picked up sometime this week.
- Tried to make contact with the site manager @ Cielo vista apt about the blight that next to the dumpsters couches, and mattress I did leave a door tag to contact me.
- I received a call from the town hall about a dog that was loose when I arrived to the address the residence @ 700 warden St let me know where the dog was at I was able to get the dog and put him in my unit and had a tag call the number on the tag and got the address of the owner took the dog to the residence @ 08 Adams St did give them a warning.
- I was able to make contact with residence @ 111 Garcia St about their dog running at large I did let them know that there dog had to be in a

leash or in a kennel and that it would be the last warning they would be receiving and next time it would be a citation.

- I picked up a dog on Garcia St and I took him to the owner @ 375
   Washington St I did let the residence know that I had picked up the dog on Garcia St and it wasn't the first time. Then he started to yell at me and telling me that why am I only targeting him I did let him know that I'm only doing my job as code enforcement and animal control and that it would be the last warning and next time he would be getting a citation.
- I spoke to the residence @ 235 Washington St about her dog being lose and I advised her that her dog had to be in the yard or on a leash or kennel and couldn't be running at large.

- Spoke to the residence @ 412 Fullenwider about them throwing their pig poop on the towns right away I did let them know that they had to pick it up and throw it in the trash or throw it back in their yard. - I tried to make contact with the site manager @ Valle Vista apartments for a couch they have next to the dumpster and it's been there for a couple of weeks I left a door tag so they can get a hold of me.
- The residence @ 397, s Garcia St put in for a building permit application to build a shed I went out to the residence to see where they are going to build the permit and it's on a good location so I approved the permit.
- I went to go talk to the residence @ 592, Warden St about a property they own on Hwy 112 and it has a lot of blight I couldn't make contact with the residence so I will try again on Oct 29, 2024
- went to go check on a building permit application they put in for a face @
   275, E Hwy 112 they are building it on the place there one fence was at so I approved the fence permit.

- I spoke to the residence @ 557 2<sup>nd</sup> E St about a car they have parked on the towns right away with expired plate did let the residence know they had to get the plates and registration up to date or park it tin their yard. The residence did let me know he would get it moved into his yard sometime this week.
- I did a checkup with the residence @ 375 W 6<sup>Th</sup> St about a chicken coop they had next to the neighbor fence and they did remove the chicken coop.
- I spoke to the manager @ 2098 Hwy 112 "Dollar general" about their cardboard carts rolling to the Hwy and hitting cars I did advise them to tie down their car so they can salve their problem of the carts going everywhere.
- I was able to make contact with the residence @ 592 Warden St about the property they have on Hwy 112 I did let them know about the blight situation they have on the property. I also let them know that they have to work on the blight situation and gave them two weeks to get it picked up and removed from property the residence did tell me they would remove the blight out of the property in the next two weeks.
- I spoke to the residence @ 595 Miles St about their dogs running at large and killing another residence chickens I did let the dog owner that he had to his dogs tied or make sure they don't leave the property. I also did let them know that I would be talking to the other residence to see if they wanted to press charges for the dogs killing all of their chickens and would be back the next day with an answer.
